## OCCUPANCY AND USE <br> ANGELES NATIONAL FOREST

Pursuant to 36 CFR 261.50(a) and (b), to provide for public safety, the following acts are prohibited within the Santa Clara/Mojave Rivers Ranger District of the Angeles National Forest. This Order is effective from December 18, 2008 through December 17, 2009.

1. Going into or being upon the Posey Canyon/Ridge Route Pipeline Rehabilitation Area, as described in Exhibit A and shown on Exhibit B. 36 CFR 261.53(e).
2. Being on any National Forest System road within the Mosey Canyon/Ridge Route Pipeline Rehabilitation Area, as described in Exhibit A and shown on Exhibit B. 36 CFR 261.54(e).
3. Being on any National Forest System trail within the Posey Canyon/Ridge Route Pipeline Rehabilitation Area, as described in Exhibit A and shown on Exhibit B. 36 CFR 261.55(a).

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

1. Persons with a permit from the Forest Service specifically authorizing the otherwise prohibited act or omission.
2. Owners or lessees of private lands within the Posey Canyon/Ridge Route Pipeline Rehabilitation Area are exempt from the prohibitions listed above to the extent necessary to gain access to their land.
3. Persons who reside on private lands within the Pose Canyon/Ridge Route Pipeline Rehabilitation Area are exempt from the prohibitions listed above to the extent necessary to gain access to their residences.
4. Persons with a Special Use Permit from the Forest Service authorizing work on the Oil Pipeline Rerouting/Rehabilitation Project and their employees, contractors, or agents are exempt from the prohibitions listed above to the extent authorized by the Special Use Permit.
5. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions contained in 36 CFR Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than $\$ 5,000$ for an individual or $\$ 10,000$ for an organization, or imprisonment for not more than six months, or both, 16 USC 551 and 18 USC 3559, 3571, and 3581.

The Posey Canyon/Ridge Route Pipeline Rehabilitation Area is described as follows:
Beginning in Township 7 North, Range 18 West, San Bernardino Base and Meridian (SBBM) at the intersection of the west section line of Section 26 and the eastern roadway edge of Interstate 5; then continue north along the west section line of Section 26 to its intersection with the north section line of Section 26 ; then continue east along the north section line of Section 26 to its intersection with the west section line of Section 24; then continue north along the west section line of Section 24 to the intersection with the north section line of Section 24 ; then continue east along the north section line of Section 24 to its intersection with the west section line of Section 18, Township 7 North, Range 17 West, SBBM; then continue north along the west section line of Section 18 to its intersection with the north section line of Section 18; then continue east along the north section line of Section 18 to its intersection with the west section line of Section 17; then continue south along the west section line of Section 17 and Section 20 to its intersection with the south section line of Section 20; then continue east along the south section line of Section 20 to its intersection with the west section line of Section 28; then continue south along the west section line of Section 28 and Section 33 and the west section line of Section 4, Township 6 North, Range 17 West, SBBM to its intersection with the east section line of Section 9, Section 16, Section 21 and $\frac{1}{4}$ mile south of the north section line of Section 28, Township 6 North, Range 17 West, SBBM; then continue west $1 / 4$ mile into Section 28 ; then continue south $1 / 4$ mile into Section 28 ; then continue west $1 / 4 \mathrm{mile}$ into Section 28 ; then continue south $1 / 4$ mile into Section 28 ; then continue west $1 / 4 \mathrm{mile}$ into Section 28; then continue south $1 / 4$ mile to the south section line of Section 28; then continue west along the south section line of Section $28 \frac{1}{4}$ mile; then continue north to the north section line of Section 28 ; then continue west along the north section line of Section 28 and Section 29, Township 6 North, Range 17 West, SBBM, to its intersection with the east roadway edge of Interstate Route 5; then continue northwesterly along the east roadway edge of Interstate Route 5 to the starting point.
