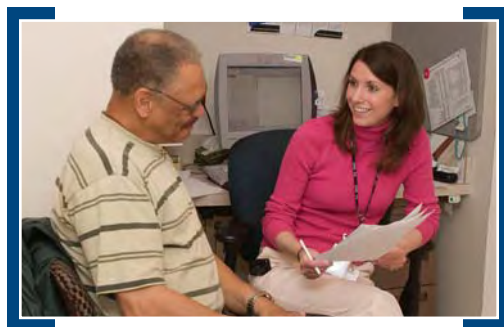

It is my goal to ensure that all veterans are 100% satisfied with the care and services they receive at VISN 4, therefore we will continue to research new ideas and programs to continue to improve and revolutionize the way we care for our veterans. In fiscal year 2007 VISN 4 obligated more than \$85 million in capital improvement projects to ensure that veterans are receiving top-notch care in state-of-the-art facilities.

Access to care for veterans is a top priority for VISN 4. Recent data shows that 99% of veterans are able to receive primary care appointments within 30 days of their desired date and 98% are able to receive specialty care appointments within 30 days. VISN 4 leadership's goal is to ensure that 100% of veterans receive appointments within 30 days of their desired date. VISN 4 ranks #1 nationally, for both new and established patients, for scheduling a primary care appointment as soon as wanted for veterans.

VISN 4 is an integrated services network consisting of ten VA Medical Centers, including one three-division health care system, and 44 primary care community-based outpatient clinics. VISN 4 serves veterans in 104 counties in the states of Pennsylvania, West Virginia, Delaware, New Jersey, New York and Ohio and offers comprehensive services ranging from preventive screenings and primary care to long-term care.

All ten VISN 4 facilities have fully implemented the MRSA Prevention Initiative in their acute care divisions. VA Pittsburgh Healthcare System (VAPHS) leads these efforts based on its success in reducing MRSA rates by 60%.

VISN 4 offers unique and specialty care for veterans including one of the country's 21 VA Polytrauma System of Care units, located at Philadelphia VAMC. Polytrauma care is for veterans and returning service members with injuries to more than one physical region or organ system, one of which may be life threatening, and which results in physical, cognitive, psychological, or psychosocial impairments and functional disability. Some examples of Polytrauma include: traumatic brain injury (TBI), hearing loss, amputations, fractures, burns and visual impairment. VISN 4 also has a National Liver and Kidney Transplant Center as well as a National Bariatric Surgery Center, both located at VA Pittsburgh Healthcare System.

VISN 4 is reaching out to returning veterans and has appointed four transition patient advocates, who work directly with OEF/OIF veterans to ensure they are receiving the care and services

that they need, and we also implemented direct-dial phone lines for veterans. VISN 4 supported the No Veteran Left Behind initiative, ensuring that more than 94% of existing patients were seen within 30 days and seven of our 10 facilities met or exceeded the measure.

VISN 4 allocated \$49.8 million for research projects in fiscal year 2007 and has research centers throughout our network that are making great strides in enhancing and creating new and improved treatments and services for our veterans to include improving pain control for OEF/OIF veterans with combat injuries.

In FY2007 \$14.6 million was allocated to fund the expansion of our mental health services and programs and more than 220 new positions were created to join our staff of mental health professionals. More than \$85 million was obligated in capital improvement projects through our Non-Recurring Maintenance program to ensure that our veterans are receiving the best care in the best facilities.

VISN 4 will continue to strive to meet the needs and exceed the expectations of our veterans.

system, serving a veteran population of more than 360,000 throughout the tri-state area of Western Pennsylvania, Ohio, and West Virginia.

Joining VA as a biomedical engineer in 1987 at VA Palo Alto Healthcare System in California, Mrs. Wolf has worked in VA Central Office and VISN 4, as well as serving as Associate Director of VAPHS before becoming Acting Director at Butler VAMC, Pennsylvania. She also served as the Director of Lebanon VAMC in Pennsylvania.

VAPHS consists of three divisions operating under one management. What is now known as the Heinz Division was originally built in 1925. The University Drive and Highland Drive VA Medical Centers were activated in the 1950s; they were consolidated as the VA Pittsburgh Healthcare System in October 1996. VA Pittsburgh Healthcare System is a tertiary referral center for the western half of VISN 4.

On May 7, 2004, VAPHS was approved for a nearly \$300 million dollar major construction project. The purpose of this project is to consolidate the three-division health care system into two divisions, to accommodate the current and projected workload and to provide a state-of-the-art, improved care environment while reducing operating expenses, and enhancing services. Construction is taking place at both the University Drive and Heinz Divisions in order to relocate the functions currently housed at the Highland Drive Division. VAPHS also supports three Veterans Outreach Centers in Pittsburgh, PA; McKeesport, PA; and Wheeling, WV.

VAPHS has the distinction of being awarded four National Research Centers of Excellence for the Geriatric Research, Education, and Clinical Center (GRECC); Human Engineering Research Laboratories (HERL); Mental Illness Research, Education and Clinical Center (MIRECC); and Center for Health Equity Research and Promotion (CHERP).

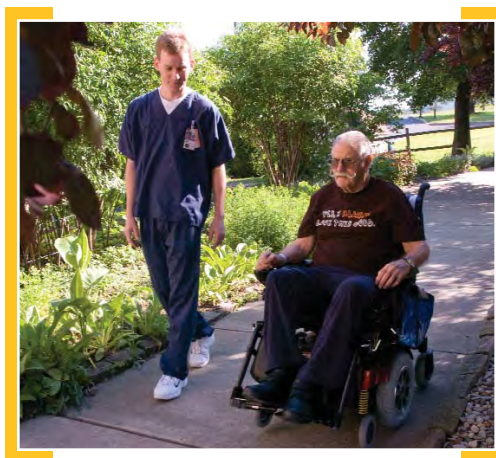
VA Butler Healthcare's facility is located on an 88-acre campus three miles northwest of Butler, PA on Route 356 (New Castle Road).

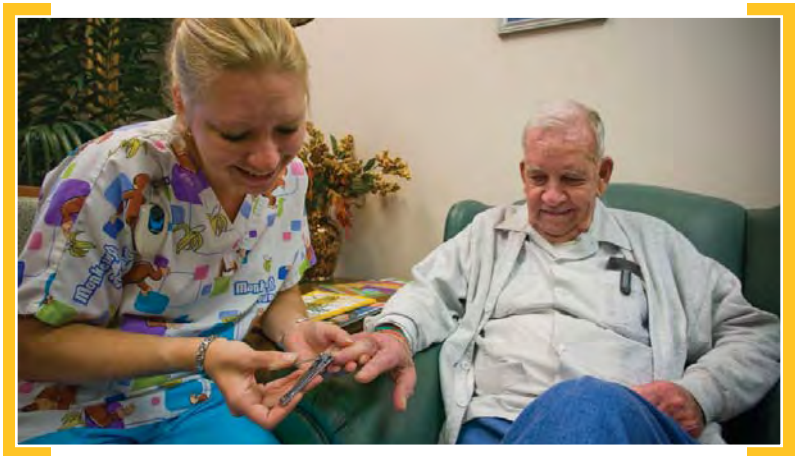

The Philadelphia VA Medical Center has the distinction of being awarded several National Research Centers of Excellence including: Parkinson's Disease Research, Education and Clinical Center (PADRECC); Mental Illness Research Education and Clinical Center (MIRECC);
