

Order No. 06-08-09

National Forest System Roads

Lassen National Forest

Pursuant to 36 CFR 261.50(b), and to provide for public safety, the following acts are prohibited within the Lassen National Forest. This Order is effective from December 26, 2008 through March 31, 2009. For the purposes of this Order, a wheelchair is not considered to be a motor vehicle.

1. Using a wheeled motor vehicle on the National Forest System roads listed below and shown on Exhibits A, B and C. 36 CFR 261.54(a).

Eagle Lake Ranger District (Exhibit A):

- a. Forest Road No. 32N08.
- b. Forest Road No. 32N10 (10 Road).
- c. Forest Road No. 21.
- d. Forest Road No. 30N29.
- e. Forest Road No. 29N46.
- f. Forest Road No. 29N85 (Hamilton Mountain Road).
- g. Forest Road No. 30N07.
- h. Forest Road No. 29N03 (Willard Creek Road).
- i. Forest Road No. 30N03 (Hog Flat Road).

Hat Creek Ranger District (Exhibit B):

- a. Forest Road No. 32N31.
- b. Forest Road No. 32N44Y.
- c. Forest Road No. 33N16.
- d. Forest Road No. 32N30.

Almanor Ranger District (Exhibit C):

- a. Forest Road No. 10.
- b. Forest Road No. 26N27 (Scotts John Tie Road).
- c. Forest Road No. 27N06 (Colby Mountain Road).
- d. Forest Road No. 29N48 (Turner Mountain Road).
- e. Forest Road No. 29N60.
- f. Forest Road No. 29N62.
- g. Forest Road No. 29N67.
- h. Forest Road No. 30N07 (Swain Mountain Road).

2. Using a wheeled motor vehicle on the Bizz Johnson Trail, as shown on Exhibit A. 36 CFR 261.55(b).

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

1. Persons with a permit from the Forest Service specifically authorizing the otherwise prohibited act or omission.
2. Any Federal, State, or local officer or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

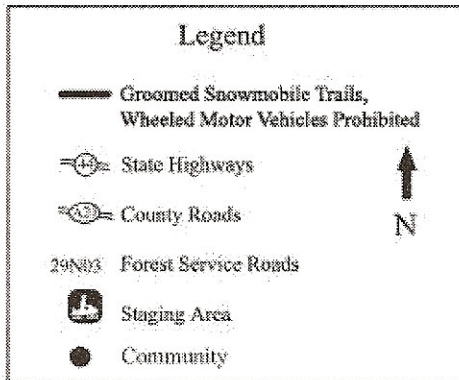
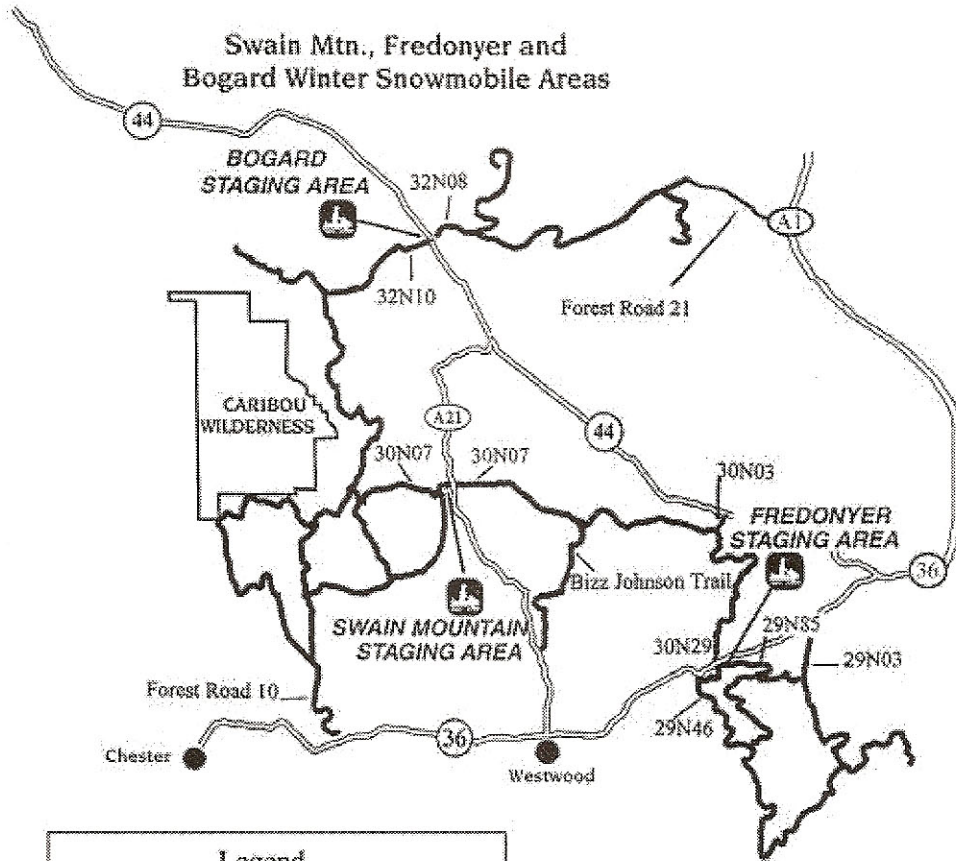

# Exhibit B - Forest Order # 06 - 08 - 09

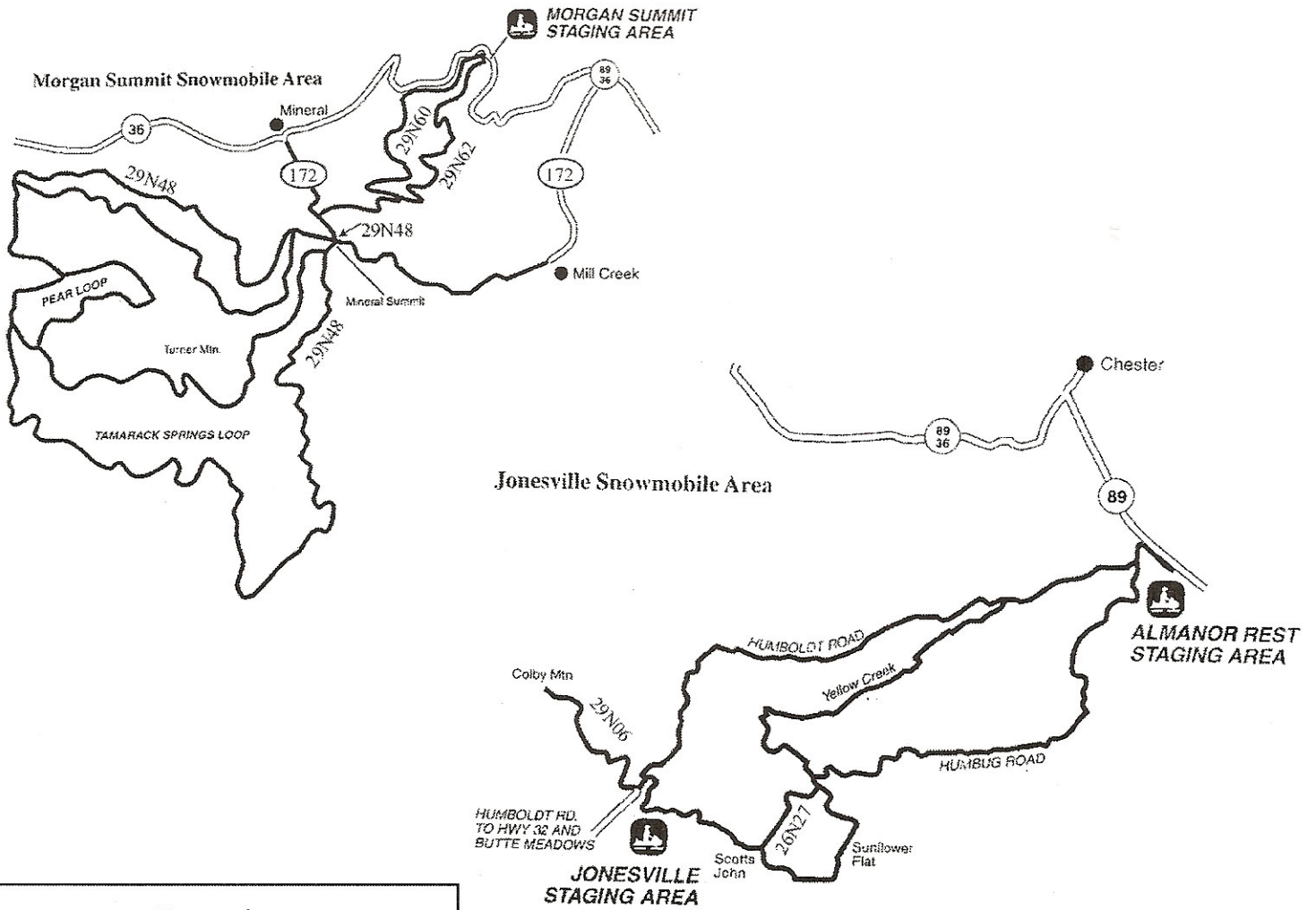



