CD-06-15-S—Angel's Rest Trail Relocation

DECISION MEMO and CONSISTENCY DETERMINATION for the RELOCATION OF ANGEL'S REST TRAIL

USDA Forest Service, CRGNSA NATIONAL SCENIC AREA

PROPOSED ACTION

The Columbia River Gorge National Scenic Area is proposing to spend federal dollars for a 1,000 foot reroute and rehabilitation of Angels Rest Trail #415 on a portion of the trail located in Bridal Veil State Park. The rerouted section work would include grubbing, clearing and construction of tread. The rehabilitation section work includes installing water bars or check dams, covering with dead branches, stems and leaves and planting native vegetation on the old trail bed. No trees greater than 12 inches will be cut.

LOCATION

The project is located in T1N, R5E, Sec 14, SE/SW, Taxlot 200 on Oregon State Park land.

PURPOSE AND NEED

The purpose of the project is to protect the natural resources in the area and to improve the quality of the trail. The trail is currently eroding in this section.

DECISION

I have decided to approve the proposed action with the implementation requirements described on starting on page two of this document. The rationale for my decision is based on: 1) the proposed action fully meeting the purpose and need; 2) consistency with the Mt. Hood NF Forest Plan and the CRGNSA Management Plan; 3) review of the enclosed findings-of-fact; 5) review of the public comments on the project, and 6) review of the scenic, cultural, natural, and recreation specialist input to the project.

SCOPING AND PUBLIC INVOLVEMENT

This project has appeared on the CRGNSA Schedule of Proposed Actions (SOPA) since 2005. A notice to interested parties was sent on March 23, 2007 for a 10-day comment period. One comment letter was received and was considered during the consistency review process. The enclosed findings of fact respond to public comment.

REASONS FOR CATEGORICAL EXCLUSION

It is my determination that this action may be categorically excluded from documentation in an EA or EIS as it is within December 8, 2006 Forest Service Handbook (FSH) 1909.15, Section 31.124 concerning the repair and maintenance of trails.

EXTRAORDINARY CIRCUMSTANCES

I have determined that there are no extraordinary circumstances that indicate a presence of possible significant effects as supported by the enclosed findings of fact as well as biological and cultural evaluations.

MT. HOOD NF LAND AND RESOURCE MANAGEMENT PLAN and the COLUMBIA RIVER GORGE NATIONAL SCENIC AREA ACT AND MANAGEMENT PLAN and OTHER APPLICABLE LAWS.

Based of the enclosed Findings of Fact, I also find that this project is consistent with applicable laws, the Columbia River Gorge National Scenic Area Act and Management Plan and the Mt. Hood National Forest Plan as amended by the Northwest Forest Plan provided that it is implemented as described in the enclosed CRGNSA Consistency Determination Findings of Fact, referenced as CD-06-15-S, and that the following conditions are applied:

- 1. The project shall not commence until the project Manager has received a land use decision or letter of agreement from Multnomah County.
- 2. Should any historic or prehistoric cultural resources be uncovered during project activities, the applicant shall cease work and immediately notify the CRGNSA office and the Oregon Office of Archeology and Historical Preservation. The applicant should also notify the Indian Tribal governments within 24 hours if the resources are prehistoric or otherwise associated with Native American Indians.
- 3. Hand sawing or machine operations shall be done outside of March 1 to August 31. Activities that do not raise noise levels above the ambient level do not require a restriction.
- 4. Disturbed soil shall be seeded with native species and erosion shall be controlled until plants are established.

<u>Implementation Date</u>: This project may begin immediately as long as it complies with the conditions as described in item 1-4 above. This decision expires on April 3, 2009. If implementation has not commenced before that date, a new consistency review or extension shall be required.

Appeal Opportunities: A written request for review of the Consistency Determination, with reasons to support the request, must be received within 20 days of the date shown with the Area Manager signature below. 

FINDINGS OF FACT:

The following findings of fact contain the applicable standards and guidelines from the Revised CRGNSA Management Plan. The Management Plan, as revised and adopted in 2004, is in effect. The CRGNSA Management Plan standards and guidelines are displayed in **bold type**. The findings are displayed in regular type.

A. Project Proposal

The Columbia River Gorge National Scenic Area is proposing a 1,000 foot reroute and rehabilitation of Angels Rest Trail #415. The rerouted section work would include grubbing, clearing and construction of tread. The rehabilitation section work includes installing water bars or check dams, covering with dead branches, stems and leaves and planting native vegetation on the old trail bed. No trees greater than 12 inches will be cut.

B. Land Use Designations

1. The Management Plan, Part II, Chapter 7 (General Policies and Guidelines), states:
