### VA DATA AND INFORMATION SYSTEMS

#### **1. DSS NDE File Structure Changes**

DSS has reorganized the clinical National Data Extract Files (DSS NDE) by merging the inpatient and outpatient data into a single file for each VISN for each year. DSS is placing the reorganized files onto Direct Access Storage Devices (DASD) at the Corporate Franchise Datacenter (CFD) in Austin to make them more readily accessible. Moving the NDE files to DASD should improve performance and reduce user waiting time for these large files. Security requirements for access remain unchanged. The new name mask is: RMTPRD.MED.DSS.SAS.FY&&.VISN&&.ndename.

## **2. 2007 Corporate Databases Monograph Issued**

The Veterans Health Administration (VHA) National Data Systems (NDS) division of Health Informatics and Information Resources, VHA Office of Information, has issued the *2007 VHA Corporate Databases Monograph*. There are just over 100 national databases described in the monograph, and for each database there is an overview of features and a table of pertinent details about it. This monograph serves as a resource for VHA when performing analyses for policy, management and clinical decision making, as well as serving as a reference to health services researchers regarding the existence and content of national databases. ## **3. Pre- and Post-Deployment Health Data for Discharged and Non-Discharged Service Members**

Department of Defense (DoD) deployment assessments (pre-deployment and post deployment health assessments since December 2005 and post deployment health reassessments since December 2006) are being pushed to the VHA via the Federal Health Information Exchange (FHIE) when service members are *discharged* from military service, with further updates for those patients who are referred to VA for follow-up. These data will also be available for *non-discharged* service members referred to a VA medical center. One-record-at-a-time access to these cases is provided through Computerized Patient Record System (CPRS) remote data view or VistAWeb.
