VA DATA AND INFORMATION SYSTEMS:

1. VIReC Data Alert Regarding Duplicate Prosthetics Encounters

Duplicate prosthetics encounters (Stop Code = 423) were erroneously entered into the Medical SAS outpatient datasets from April 14 – June 13, 2008, but only from the Tuscaloosa VA (Station 679). The specific datasets affected are:

- MDPPRD.MDP.SAS.SE08(0)
- MDPPRD.MDP.SAS.SF08(0)
- MDPPRD.MDP.SAS.IE08(0)

The Veterans Health Administration (VHA) Office of Information (OI) National Patient Care Data (NPCD) plans to correct the outpatient datasets as follows: 9/8/08 – Inpatient Encounter (IE); 9/15/08 – Outpatient Visit (SF) and Outpatient Event (SE). The final fiscal year 2008 (FY08) datasets will not have this problem. Researchers need only be concerned if they have used the FY08 interim outpatient datasets (IE, SF, SE) since April 25, 2008.

2. Hospice and Palliative Care Workload Capture

VHA Directive 2008-041, dated August 4, 2008, defines the VHA provision of Hospice and Palliative Care (HPC) and the VHA policy for coding this care. Coding quality is important for funding allocation and strategic planning, and for research purposes. Attachment A of the directive contains detailed coding rules. 3. Assignment of Station Number Suffix Identifiers for CBOCs

VHA Directive 2008-048, dated August 22, 2008, provides policy for the assignment of station number suffix identifiers for Community-Based Outpatient Clinics (CBOCs). CBOCs are VA operated and funded facilities that are distinct from, but associated with a parent medical facility. CBOCs include all types of VA outpatient clinics with the exception of hospital-based, independent (fiscally self-contained), and mobile clinics. This new directive aims to improve the tracking and reporting of CBOC workload, especially given the increased emphasis on establishing new CBOCs. New CBOCs must be approved by the Under Secretary for Health, congressionally endorsed, and will now be assigned a suffix identifier at the time of approval. 5. Proposals for NIH Conference on Implementation Due September 26

The National Institutes of Health (NIH) are calling for proposals for the 2nd Annual NIH Conference on the Science of Dissemination and Implementation: Building Research Capacity to Bridge the Gap from Science to Service. Proposals are due on September 26, 2008. Submissions fall into three categories: (1) think tanks; (2) individual or panel oral presentations; and (3) posters. The range of scientific topics given priority for presentation are included in the Trans-NIH Program Announcement, *Dissemination and Implementation Research in Health* at http://grants.nih.gov/grants/guide/pa-files/PAR-07-086.html.
