## 1. New VIReC Research Users Guide: VHA Pharmacy Prescription Data

A beta version of the VIReC Research User Guide: VHA Pharmacy Prescription Data is now available on the VIReC Web site at http://www.virec.research.va.gov. This guide describes the sources of VA patient-level prescription data available to researchers. It also provides detailed descriptions of variables in the Pharmacy Benefits Management (PBM) Database and the recently released Decision Support Services (DSS) National Data Extracts (NDE) Pharmacy SAS® Datasets. ### 2. VBA BIRLS Death File Updated

In August 2003 the Austin Automation Center (AAC) completely refreshed the Beneficiary Identification Records Locator System (BIRLS) Death SAS dataset. This dataset contains veteran patient deaths reported to the Veterans Benefits Administration (VBA). Previously, although the dataset was updated on a regular basis with information received from the VBA, any death information potentially misreported was not removed from the dataset. Henceforth, the BIRLS Death SAS dataset will be refreshed on a regular basis every January. The SAS refreshed dataset name is MDPPRD.PRO.SAS.VHA.BIRLS.DEATHS(0). A copy was made of the BIRLS Death SAS dataset before it was refreshed, and it is named MDPPRD.PRO.SAS.VHA.BIRLS.DEATHS.AUG03. #### 5. Release of AHRQ Inpatient Quality Indicators Version 2.1 Revision 2

AHRQ has announced an update of the Inpatient Quality Indicators (IQI), Version 2.1, Revision 1, that incorporates changes to ICD-9-CM codes and DRGs effective 10/1/03 (FY2002) and 10/1/02 (FY2003). With this update the IQI definitions now incorporate ICD-9-CM codes valid from October 1, 1994,
