1. VHA Office of Information: Data Standardization

Per the VHA Office of Information's Top OI issues, the initial meeting of VHA representatives tasked to address data standardization was held in January 2002. Participants included representatives from OI, the Chief Network Office, the Office of Policy and Planning, and the Office of Quality and Performance. The group discussed the need for standardization for the communication and exchange of clinical data, and the relevance of this effort to the success of the Health Data Repository. The group recognized the importance of collaborating with other parties including Department of Defense, Kaiser Permanente, Indian Health Service, and standards organizations. The IT Architecture Office recommended that standardization focus on three areas: 1) controlled vocabularies and code sets; 2) Meta data standards; and 3) interchange standards, including encryption, communication, and document and context naming. A preliminary strategy document is being prepared that will address these components.

2. VHA Office of Information/VHA Employee Education System: Camp CPRS 2002

The OI National Training and Education Office (OI NT&EO) has announced the Physician and Clinical Informatics Team Training Program, "Camp CPRS 2002, "Above and Beyond." This training will be held from Monday, April 29 through Friday, May 3, 2002 in Atlanta, Georgia, and is sponsored jointly by the VHA Office of Information and the VHA Employee Education System.

Camp CPRS 2002 will highlight new innovations towards patient care through hands-on classes, breakout sessions, software demonstrations, exhibits, networking, and other special events. This year's Camp CPRS features "tracks" for different types of attendees including: 1.) Clinicians (with a special 2 day Chief of Staff track), 2.) Direct Care Nurses, 3.) Clinical Informatics Support Staff (including Health Information Management Specialists), and 4.) Pharmacists

3. US Census 2000 Data Available

The U.S. Census Bureau recently released the first two major sets of data from the 2000 Census: Redistricting and the "Short Form" (SF1). GeoLytics offers these products in two easy-to-use formats either at the Block level or at the Block Group level and larger geographies. The data has been compressed so that it generally fits on 1 disk and it comes with built-in mapping capabilities, based upon the new Census 2000 boundaries. Geolytics states that you can generate full-blown maps or tables can be generated and you can export the data into a statistical software package, mapping or other software package. 4. **NIH Draft Statement on Sharing Research Data**

NIH is developing a new statement on sharing research data that will expect and support the timely release and sharing of final research data from NIH-supported studies for use by other researchers. Investigators submitting an NIH application will be required to include a plan for data sharing or to state why data sharing is not possible. This is an extension of NIH policy on sharing research resources. NIH invites comments on this draft statement. Following consideration of public comments and appropriate revisions, it is expected that the new policy will be announced on August 1, 2002 with a proposed effective date of January 1, 2003.
