## 1. FY2002 Medical SAS Datasets Reflect New VISN

### 2. VHA Handbook for Coding Guidelines Updated

The Planning Systems Support Group (PSSG) of the VHA Office of Policy and Planning has issued the End of Fiscal Year 2001 Report of its VA Site Tracking (VAST) database. The report provides, in tables, graphs, and maps, information on the number and types of VHA facilities nationally and by VISN. ### 5. OI Race and Ethnicity Project Approved for Implementation

Implementation of the VHA Office of Information System Design & Development (SD&D) Race and Ethnicity Project has been activated, and a project plan and schedule are being developed. The project addresses the standards for Federal agencies' collection and use of race and ethnicity data that were issued by the Office of Management and Budget in October 1997. The standards specified five categories for data on race (American Indian or Alaska Native, Asian, Black or African American, Native Hawaiian or Other Pacific Islander, and White) and two categories for data on ethnicity (Hispanic or Latino and Not Hispanic or Latino). Data collection for both the race and ethnicity fields will be made mandatory, and it is expected that there will be an indicator of how the determination was made (visual or self-identification). The project will have an impact on numerous VA databases.
