

Federal OCS Oil & Gas Production as a Percentage of Total U.S. Production: 1954 - 2006

Production totals are based on total volume, not sales volume; Federal OCS natural gas production totals for 1954 until end of August 1998 were adjusted with a 1.02 conversion factor to equate to the same pressure base at which onshore production was measured. Beginning September 1998, Federal OCS production is measured at the same pressure base as onshore.
