

### **1. Estimates & Projections of Veteran Dementia Prevalence and Incidence**

The VHA Geriatrics and Extended Care Strategic Healthcare Group and the Office of the Assistant Deputy Undersecretary for Health (ADUSH) have released estimates and projections of veteran dementia prevalence and incidence for 2002-2022 for three segments of the veteran population: (a) general veteran population, (b) population enrolled in the VA health care system, and (c) population both enrolled and receiving services in the VA health care system. ### **2. 2004 Corporate Databases Monograph Issued**

The VHA National Data Systems (NDS) division of Health Data and Informatics, VHA Office of Information, has issued the *2004 Corporate Databases Monograph*. The updated monograph describes 92 VHA data sources in terms of an Overview, Features, and a Table of Important Database Characteristics. ### **3. VIREC Becomes Member of VHA Data Consortium**

Effective March 2004, VIREC's status with the VHA Data Consortium was changed from Consultant to Member, making it now one of 12 offices who are members and the only member representing VA researchers. The Data Consortium was formed in 1998 at the request of the Deputy Undersecretary for Health and under the guidance of the Chief Policy and Planning Officer (now Assistant Deputy Under Secretary for Health). Its mission includes supporting the Information Data Management Committee of the National Leadership Board, providing support for common data concerns of the member offices, providing guidance to VHA regarding data quality concerns, providing support to VHA toward enhancing its data credibility, and serving as a resource of data experience and expertise on which the VHA may draw.
