## 1. VIReC Project on Mortality Data Completed

The "VA-NDI [National Death Index] Mortality Data Merge Project," recently completed by VIReC (Min-Woong Sohn, Principal Investigator), found that the pooled use of the Medicare Files, the Social Security Administration Death Master File, BIRLS Death File, and Medical SAS Inpatient data to ascertain death compared very favorably with the NDI. VIReC is following up the study by preparing a technical report to appear on the VIReC Web site and a manuscript for publication, as well as exploring with other VA offices the development of a national registry of VA mortality data.
