# 1. HSR&D 2006 Cyber Seminars on VA Databases and Methods Offered by VIReC

Faculty from VIReC will present this series of monthly informational seminars to assist VA researchers in accessing and using VA databases for research. Seminars are held on the first Tuesday of the month 1-2 PM (Eastern). Upcoming sessions include:

March 7: "Introduction to VIReC Tools for Using VA Databases," Denise Hynes, PhD, RN This session will provide an overview of the tools and resources available from VIReC, and how to access these resources on the VIReC Web site. Topics include:

- Comparison of VHA Decision Support System and Pharmacy Benefits Management databases
- Documentation of the VHA Enrollment database that is used to produce data for VHA reports
- Description of Medicare Current Beneficiary Survey and U.S. Renal Data System files which are now available, in addition to the Medicare enrollment and utilization data, from VIReC through the VA Medicare Data Merge Initiative (including how to request all these data from VIReC)

April 4: "Mortality Ascertainment: Death Where is Thy Record," Noreen Arnold, MS Mortality is one of the most frequently studied outcomes in health services research and clinical trials. In this cyber seminar, Noreen Arnold will present the results of a recent VIReC study that:

- examined the completeness and reliability of death dates found in VA data sources
- determined the costs and benefits associated with use of alternative sources for death ascertainment
- developed a strategy for building a central database or registry of death data that would be used by VA researchers for death ascertainment

The Office of Policy of the Department of Veterans Affairs Assistant Secretary for Policy, Planning, and Preparedness Office conducted a national survey of veterans. The purpose of the telephone survey was to collect information relevant to planning and budgeting VA programs. Information was collected on a national sample of veterans, as well as a sample of veterans selected from VA Compensation and Pension, and Health Care Enrollment files.

#### 6. New Veteran Indicator Flag (VETIND) Added to Outpatient Medical SAS Datasets

A new field, Veteran Indicator, has been added to the Medical SAS Outpatient Datasets. The SAS variable is VETIND, the format is \$XXYN with possible values of YES, NO or space and the label is Veteran Indicator.
