2. Cyber Security and Privacy Training for FY2006 due by June 30

The Secretary of Veterans Affairs issued a reminder that the annual General Privacy Training and VA Cyber Security Awareness Training for 2006 are due by June 30. All employees are required to sign a Statement of Commitment and Understanding. By signing this statement, employees confirm their understanding of the training, the consequences for noncompliance, and their commitment to protecting sensitive and confidential information in the Department of Veterans Affairs.

The VHA provides five current offerings to all VA employees and related VA workers to help avoid delays caused by congestion on available sources: (1) VA Cyber Security Awareness FY06 - Web/Computer-Based; (2) Privacy: It's Everyone's Business – Video; (3) VA Privacy Awareness - Web/Computer-Based; (4) VHA Privacy Policy FY06 - Web/Computer-Based; (5) VHA Provider Privacy Training – Video.

VA employees can go to the VA Learning Catalog on the Intranet (address given in the Intranet version of this *Data Issues Brief*) to access any of the Web courses or to find out how to view the videos. Type "Security Alert" in the keyword search and hit "Go." You should contact your information Security Officer or Privacy Officer if you have questions or need further information.

3. June 20 Clinical Informatics Cyber Seminar Features Evaluation and Clinical Informatics

This month, VIREC and the Center of Excellence on Implementing Evidence-Based Practice feature Dr. Annette Valenta in the Cyber Seminar on Clinical Informatics. Dr. Valenta is Professor and Department Head, Biomedical and Health Information Sciences, College of Applied Health Sciences, University of Illinois at Chicago. Dr. Valenta's research assesses provider readiness to work with computerized decision support and formulates recommendations for design of computerized decision support based on social and organizational factors. The seminar takes place on Tuesday, June 20 at 12 noon ET

5. New VHA Directive for Surgical Case Coding

The Veterans Health Administration (VHA) released a new directive (2006-0035) for International Classification of Diseases 9th Revision Clinical Modification (ICD-9-CM) and Current Procedural Terminology, 4th Edition (CPT-4) surgical code assignments. The VHA policy ensures ICD-9-CM and CPT-4 surgical coding accuracy within the surgical package for each VA health care facility. 6. New HERC Guidebook Released: Researchers' Guide to ALBCC

The Health Economic Resource Center (HERC) released a guidebook that provides information on how the Account Level Budget Cost Centers (ALBCC) is created, how to access ALBCC, and the variables included.
