VIReC UPDATES:

1. VIReC's Internet Website Address Has Changed

Please update your Bookmarks to the new VIReC Internet website address: http://www.virec.research.va.gov/. Users of the VIReC Internet and VA Intranet sites will notice that we have converted to the VHA "look and feel." Users should also note that some information formerly found on the Internet site can now only be found on the Intranet site. 2. Report on 2005 Survey of Veterans from the VA Office of the ADUSH for Policy and Planning

The VA Office of the Assistant Deputy Under Secretary for Health (ADUSH) for Policy and Planning has published the "2005 Survey of Veteran Enrollees' Health and Reliance upon VA with Selected Comparisons to the 1999–2002 Surveys" on the VA Intranet (address given in the Intranet version of this *Data Issues Brief*). The purpose of the VHA Survey of Enrollees is to provide information that is incorporated into annual VHA projections of enrollment, utilization, and expenditures. The survey was first conducted in Fiscal Year 1999. It provides critical information about the veterans VHA serves: demographic characteristics; other eligibilities and resources; health status and need for care; and self-reported utilization of VA and Non-VA care.

3. Reassignment of ADUSH Monthly Enrollment File to New Austin Automation Center Name Space

The Austin Automation Center (AAC) moved the SAS-formatted ADUSH Enrollment files from the RMTPRD.R101REN name space to a new MDPPRD name space. The AAC is housing the historical data files beginning with data in 2000 in the new name space. The move was effective August 24, 2006. VIReC incorporated the name space change in the newly published ADUSH Monthly Enrollment File Research User Guide 1999-2006 available at the VIReC Internet: http://www.virec.research.va.gov/.

4. Encounter Data Available at AAC for Inpatients Who Receive Outpatient Services

Inpatient Encounter (IE) files are available at the AAC with data starting in FY2005. The outpatient encounters documented in this file (e.g., EKG, MRI, Social Work Services, ultrasound, etc.) are for patients seen in one of the VHA outpatient clinics while they have an inpatient status. The file uses VistA "inpatient status" of acute care, extended care, observation care, or non-VA care status to select encounters to include. The Outpatient Encounters (SE) files exclude services that are included in the IE files. Although VistA assigns these patients inpatient status, the IE files use CPT codes because patients receive services at outpatient clinic stops. The AAC file is "MDPPRD.MDP.SAS.IEyy" where "yy" refers to the two-digit year. The file sorts the encounter records by SCRSSN, VIZDAY, and STA6A.

5. New DSS Reports

The August-September 2006 issue of *DSS Matters* issued by the Decision Support Office describes two new Decision Support System reports now available. "Geriatric Primary Care: Workload, Utilization and Cost" was added 7/6/06, as was "Telehealth Workload."
