1. VIREC Medicare Documentation Update Provides Info about Data Usability

VIREC now has detailed summary information about VA Medicare claims data including variable listings (SASTM Proc Contents) for 1997 through 2004 data on our Intranet Web site. We have also added descriptive summary information (Select Frequencies and Minimum/Maximum Values) for the following Medicare files: Vital Status (through 2005), Denominator and MEDPAR (through 2004):

2. New VA Vital Status Datasets at AAC Will Improve Mortality Ascertainment Research

Two new datasets for assessing mortality are now available at the Austin Automation Center (AAC) thanks to National Data Systems (NDS) and the VHA Data Consortium efforts. The two new VA Vital Status files combine death dates from all sources currently available to VA researchers, including the Medical SAS Inpatient Datasets, the Veterans Benefits Administration's (VBA) Beneficiary Identification and Resource Locator System (BIRLS), the Medicare Vital Status file, and the Social Security Administration (SSA) death file. The methods are based on HSR&D Service-supported research (SDR 03-157) undertaken at VIREC (<http://www.pophealthmetrics.com/content/pdf/1478-7954-4-2.pdf>).

The two VA Vital Status datasets are the Master and Mini files. The Master file contains one record for each SSN-date of birth (DOB)-gender combination. It provides all dates of birth, genders, and dates of death found for each SSN. The Mini file contains one record for each SSN and provides the "best" dates of birth and death. Both of these files include the VA's Scrambled SSN. A crosswalk file to real SSNs is available for researchers requiring real SSNs. These files are now available at AAC. Researchers must follow the real SSN clearance process to use the new functional task code assigned to the Vital Status files: <http://www.virec.research.va.gov/DataSourcesName/VitalStatus/VitalStatus.htm>.
