## ***VA Information Resource Center Data Issues Brief June, 2001***

### **1. HERC Inpatient Average Cost Databases Available**


The Health Economics Resource Center (HERC) in Palo Alto recently announced the release of average cost inpatient datasets for FY98. There are three datasets for FY98: a discharge dataset (dischg98), an acute medical-surgical dataset (mdsrg98), and non medical-surgical dataset (nmdsrg98). These datasets are accessible to VA researchers with appropriate access (adding functional task code '110AC03' to your user Time Sharing Agreement via VA form 9957). ### **2. External Peer Review Process (EPRP) Database**

The Office of Quality and Performance (OQP) will be allowing researchers access to the External Peer Review Process (EPRP) database in the near future. ### **3. DSS National Data Extracts Available**

National data from the VHA Decision Support System (DSS) are available for FY99 and FY00 in SAS datasets at the Austin Automation Center. Discharge, treating specialty, and outpatient extracts have patient-level data on utilization and summary costs for categories of care: nursing, laboratory, pharmacy, radiology, and all other. Access to the extracts requires submission of an ACRS Time Sharing Request Form (VA 9957), an Agreement to Not Disclose DSS Data, and, if real SSN records are to be used, a completed VA Privacy Statement. #### 4. New HSR&D Service Resource Center Announced

In the May R&D Hotline call, Dr. John Demakis announced that Houston VAMC was the site of the newest HSR&D Resource Center. The Expedient Psychometric Education Research Team (XPERT) will aid investigators in identifying and selecting appropriate measurement tools for conducting health services research and program evaluation. The Resource Center will also develop a compendium of tested, valid research instruments and methods of measurement that are appropriate for use with veteran populations.
