VA DATA AND INFORMATION SYSTEMS:

1. VA Diagnostic Cost Group Files Available at AAC

Diagnostic Cost Group (DCG) SAS Files are now available at the Austin Automation Center (AAC) using the latest DCG release (Risk Smart 2.1.1) beginning with fiscal year 1998 (FY98) and through FY06. These data have been produced by the Management Science Group at the VHA Support Services Center (VSSC). The DCG risk score, based on age, gender and diagnoses, is cost-based and provides a relative measure for risk adjustment. Using International Classification of Disease 9th Revision (ICD-9) codes, diagnoses are converted into hierarchical condition categories which are in turn translated into a predicted cost. An individual's relative risk score is computed from the ratio of the person's predicted cost compared to the average per person cost of a given population. 2. VA Dementia Registry Summary Tables Now Available

The VHA Office of Geriatrics and Extended Care, in collaboration with the VHA Allocation Resource Center (ARC), is pleased to announce the availability of a set of Summary Tables from a new VA Dementia Registry. The summary tables include FY04 data on selected *demographics*, *service use*, *and costs* for VA patients with dementia at the VA *National and VISN levels*. The data, along with a Methods Report, are available on the ARC Intranet Web site (address given in the Intranet version of this *Data Issues Brief*). VA Dementia Projections, announced in 2004, are VA projections of *dementia prevalence and incidence through 2022*, based on national rates of dementia applied to the veteran population. Data at the *National, VISN, and State levels* are included, for three segments of the veteran population: the general veteran population; the enrolled population; and the patient population. 3. Means Test Thresholds for Calendar Year 2007

4. Pressure Ulcers to be Reported and Tracked

VHA Directive 1006-066, dated December 22, 2006 outlines a policy for reporting and tracking interventions and clinical outcomes associated with the care of patients (including Spinal Cord Injury) or nursing home residents with pressure ulcers. VA Nursing Outcome Database indicators will be similar to those currently utilized by the External Peer Review Program (EPRP) and EPRP roll-up will be used until these indicators can be fully implemented electronically.
