### VA DATA AND INFORMATION SYSTEMS:

### 1. Updates to VA Research Data Security & Privacy Web Site

The VA Research Data Security & Privacy page of the VA Research and Development (ORD) Web site (<a href="http://www.research.va.gov/resources/policies/cybersecurity.cfm">http://www.research.va.gov/resources/policies/cybersecurity.cfm</a>) now includes a link to a current list of frequently asked questions (FAQs) as well as a link for emailing data security questions to ORD. All current data security and privacy policies are listed under three overarching categories covering training requirements, transcripts from field calls, and policies, memoranda, and other requirements (i.e., directives). The new requirement for principal investigators (PIs), "Certification by Principal Investigators: Security Requirements for VA Research Information," is listed under memoranda. PIs are required by April 2007 to carry out this new annual process of submitting a data security checklist and certifying storage and security of VA research information. There are also two new directives dealing with removable storage media and the protection of personally identifiable information (PII) that are of particular note as well.

VA health services researchers may be interested in learning more about the current status of the MHV program, especially if they are considering researching the effects of patient interventions in improving the quality of VA health care.
