1. HIPAA Information for Researchers to be Presented at the HSR&D Annual Meeting

The latest VA guidance for researchers to comply with new data privacy issues in the Health Insurance Portability and Privacy Act (HIPAA) will be presented in the VIReC-sponsored workshop "HIPAA Privacy for Researchers: De bunking the Myths" at the Health Services Research & Development Service National Meeting, February 12-14, 2003. The workshop will be part of the Workshops Session 1 on Thursday afternoon, February 13, and the progress on VA's efforts to assist researchers in addressing new privacy requirements in research will be discussed

2. VHA Directive Re-Defines Priority Groups

VHA Directive 2003-003, "Provision of Hospital and Outpatient Care to Enrolled Veterans," was issued January 17, 2003, to announce Secretary Principi's decision to suspend enrolling new applicants for VHA care who are in Priority Group 8. 7. Version 2.1of the AHRQ Prevention Quality Indicators Software

Version 2.1, revision 2 (January 10, 2003) of the AHRQ Prevention Quality Indicators software is now available on the AHRQ QI website (http://www.qualityindicators.ahrq.gov) in SAS and SPSS format. The Prevention Quality Indicators (QIs) are a set of measures that can be used with hospital inpatient discharge data to identify "ambulatory care-sensitive conditions." These are conditions for which good outpatient care can potentially prevent the need for hospitalization or for which early intervention can prevent complications or more severe disease. This version is valid for use with data from October 1, 1994 to September 30, 2002.
