### 1. Submission Deadline March 12, 2003, for AMIA Conference

Proposals for presentations at the American Medical Informatics Association (AMIA) 2003 Symposium are due March 12, 2003. The Symposium, entitled "Biomedical and Health Informatics: From Foundations to Applications," will occur November 8-12, 2003, in Washington, DC. #### 2. VHA Research & Development HIPAA Privacy Rule Guidance Distributed

With a February 12, 2003, memorandum from Nelda Wray, MD, Chief, VHA Research and Development (R&D) Service, VA researchers and research administrators received a draft version of R&D guidance for implementing the requirements of the Health Insurance Portability and Accountability Act (HIPAA) Privacy Rule. The guidance document that was distributed explains the requirements of the Privacy Rule that affect researchers and discusses how VHA researchers can make sure they are in compliance. #### 3. DSS National Lab Test Extract Datasets Available

A DSS National Data Extract named "Lab Test Extract" is available at the Austin Automation Center. Ten SAS datasets comprise the Lab Test Extract: five reporting laboratory tests performed for inpatients and five reporting laboratory tests performed for outpatients. These are patient-level datasets, sorted by station, patient's scrambled Social Security Number, and date of laboratory test service. Research user documentation of the datasets will be developed by VIReC, and the availability of documentation on the Center's Web site will be announced in a future Data Issues Brief.
