# **Overview**

The Enterprise Program is composed of Forest Service employees who provide agency managers with a highly skilled workforce that is flexible in supplying on-demand services. Composed of 305 employees, it is a permanent, national Forest Service program that has contributed to critical areas of the Agency's mission for over ten years. 



# **Accomplishments**

### **Enterprise Projects Support Agency Outcomes**

In FY 2008 Enterprise Units worked on hundreds of projects in all regions of the country. Examples of recent projects undertaken by various Enterprise Units in support of all seven Agency strategic outcomes:

Maintain forest and grassland health, productivity, diversity and resistance to unnaturally severe disturbance

- Assisted with a national, broad based effort to qualitatively answer the Wildland Fire Leadership Council's (WFLC) monitoring questions that address fuels treatment effectiveness, effects on air quality, effects on water quality, effects on terrestrial habitat, and effects on aquatic habitat.
- Provided watershed improvement needs surveys and and planning development for burned watersheds on the Los Padres National Forest.

Provide and sustain long-term multiple socioeconomic benefits from the forests and grasslands

- Assisted with the analysis of surface and ground water for the Southern California Inland Feeder Project Arrowhead Tunnels.
- Continued to provide national SALHI (Sale Area Layout and Harvesting Institute) training for sustainable and environmentally sensitive logging design.

Maintain benefits of forests and grasslands by reducing and mitigating their conversion to other uses

 Completed six Pacific Crest National Scenic Trail optimal location reviews on four National Forests, a National Scenic Area and a BLM District recommending purchase of 13,097 acres.

Provide a variety of high-quality outdoor recreational opportunities

- Completed a trail assessment and condition survey, signing plan, and maintenance/rehabilitation plan for the Redbird Crest Trail on the Daniel Boone National Forest.
- Participated in numerous travel management teams and planning efforts for new off highway vehicle trail systems on National Forests in the West.

### Maintain Basic Management Capabilities of the Forest Service

 Assisted in maintaining administrative capabilities created by changes in agency processes and transformation by filling temporary gaps and by convening appropriate agency staff to clarify and streamline processes. Created products to explain changes in the administrative processes.

Enhance capacity of administrative facilities, information systems, and landownership management to support a wide range of natural resource challenges

Managed a nationwide effort to use video-teleconferencing technology.
 This technology is helping reduce travel costs and connect agency-managers on a real time basis to focus efforts on solving issues.

Inform management decisions with the best available science-based knowledge and tools

• Assisted in the quantification of the effectiveness of hazardous fuel treatments while suppressing the Ham Fire in Minnesota and other fires.

# **Financial Status**

In certain aspects the Enterprise Program manages its finances differently than other Forest Service Units, eg, they are managed out of the agency's Working Capital Fund (WFC). The Program is self-sustaining and receives no direct appropriated funding. All finances are tracked in the agency's accounting system and it reports its finances in an "income statement".



**Growth Rate** - Over the last year the revenues for the Enterprise Program grew by 25%. Since the program began in 1999 the program has averaged a growth rate of about 10% per year.

**Reserve Level** - At the end of FY 2008 the Enterprise Program's reserves for all active Enterprise Units stood at 30%, (\$10.9M /\$35.6M = 30%). The reserve, along with all of the Enterprise Program's finances, are managed out of the WCF. Agency guidelines for the WCF specify there should be a reserve level between 20-35%, putting the level of the Enterprise Program's reserves well within agency guidelines.
