Sept. 21, 2001. Introduced in the Senate. Read the first time.
Sept. 24, 2001. Ordered placed on the Senate Legislative Calendar.
Oct. 3, 2001. Cloture motion on the motion to proceed presented in Senate.
Oct. 4, 2001. Motion to proceed to measure considered in Senate by Unanimous Consent.
Oct. 9, 2001. Motion to proceed to measure considered in Senate.

Oct. 9, 2001. Cloture invoked in Senate by a vote of 97 yeas, 0 nays.
Oct. 10, 2001. Motion to proceed to consideration of measure agreed to.
Oct. 10, 2001. Considered by Senate.
Oct. 11, 2001. Passed Senate, amended, by a vote of 100 yeas, 0 nays.
Oct. 16, 2001. Received in the House, and held at the desk.
Nov. 6, 2001. Mr. Young of Alaska asked unanimous consent to take from the Speaker's table and consider.
Nov. 6, 2001. Considered by unanimous consent.
Nov. 6, 2001. The House struck all after the enacting clause and inserted in lieu thereof the provisions of a similar measure H.R. 3150. Agreed to without objection.
Nov. 6, 2001. On passage, passed without objection.
Nov. 6, 2001. Motion to reconsider laid on the table agreed to without objection.
Nov. 6, 2001. A similar measure, H.R. 3150, was laid on the table without objection.
Nov. 6, 2001. Motion that the House insist upon its amendment, and request a conference, agreed to without objection.
Nov. 6, 2001. Mr. Oberstar moved that the House instruct conferees to require the managers on the part of the House to make every effort to resolve all differences between the two Houses as soon as possible, and no later than Friday, November 9, 2001.
Nov. 6, 2001. House agreed to instruct conferees by a vote of 397 yeas 0 nays.
Nov. 6, 2001. The Speaker appointed conferees for consideration of the Senate bill and the House amendment, and modifications committed to conference: Representatives Young of Alaska, Petri, Duncan, Mica, Ehlers, Oberstar, Lipinski, and DeFazio.
Nov. 7, 2001. Senate disagreed to House amendment, agreed to request for conference, and appointed as conferees: Senators Hollings, Inouye, Rockefeller, Kerry, Breaux, Dorgan, Wyden, McCain, Stevens, Burns, Lott, Hutchison and Snowe.
Nov. 16, 2001. H. Res. 290, providing for consideration of the conference report reported to the House. H.Rept. 107-294.
Nov. 16, 2001. Conference report filed. H.Rept. 107-296.
Nov. 16, 2001. Conference report agreed to in the Senate by unanimous consent.
Nov. 16, 2001. Conference report agreed to in the House by a vote of 410 yeas, 9 nays.
Nov. 19, 2001. Approved. Public Law 107-71.
