- 11. LastAttach Unique alphanumeric page identification number used to identify the last page in an attached group of documents.
- 12. LastBates Unique alphanumeric page identification number used to identify the last page of a document.
- 13. OCR\_Text The full text of a document. The text is the result of optical character recognition (OCR) processing.
- 14. Other\_No Any stamped or computer-generated numbers other than those used in the FirstBates, LastBates, FirstAttach or LastAttach fields.
- 15. Title Document title.
- 16. Trader\_Name The name of a trader if it was evident on the document during coding.
