

Unique feature Multi-year and Ten-year Contracts...

INTEGRATED RESOURCE SERVICE CONTRACT

BLENDED-MORE SERVICES May be awarded for up to 10 years

May be multiyear (i.e. annual renewal option not required)

Required to select a source for performance on a best-value basis For both contracts and agreements.

What the authority is... Section 323 Public Law 108-7, 2003 FS and BLM, thru September 30, 2013 May enter into stewardship projects Via agreement or contract With private persons or public or private entities To perform services to achieve land management goals that meet local and rural community needs.





What the key goals include...

Road and trail maintenance or obliteration to restore water quality

- Soil productivity, habitat for wildlife and fisheries, or other resource values
- Setting of prescribed fires to improve composition, structure, condition, and health of forest stands or improve wildlife habitat





What the key goals include...

- Removing vegetation or other activities to promote healthy forest stands, reduce fire hazards, or achieve other land management objectives
- Watershed restoration and maintenance
- Restoration and maintenance of wildlife and fish habitat





What the key goals include...

- Control of noxious and exotic weeds and reestablishing native plant species
 Other appropriate land management
- goals





What stewardship contracting receipts can't be used for...

- Salaries & overhead
- Project planning or environmental analysis
- Construction of administrative or major developed recreation facilities
- Utilization of forage within an allotment that could be authorized through a grazing permit.





What stewardship contracting receipts can't be used for...

- Protection, operation, or maintenance of improvements resulting from stewardship projects.
- Inventories, Research, and Preparation & Planning of Administrative Studies
 Land Acquisition





What the planning requirements

- 1. Consistency with Land Management Plan direction.
- 2. Collaborate on end results desired.
- 3. Develop a package of projects, per planning & NEPA requirements.


