5	III. Management and Operations, 2009 Budget
6	CHAIRMAN REYNOLDS: Next up is the 2009
7	budget. A few weeks ago you were provided with a
8	summary of the Commission's fiscal year 2009 budget
9	estimate.
10	As you know, the Commission is asking for
11	a little over 11 million bucks, which is a \$2 million
12	increase over what the Appropriations Committee
13	approved in 2008. Mr. Staff Director, would you
14	please explain this recommended increase?
15	STAFF DIRECTOR MARCUS: Certainly, Mr.
16	Chairman. The increase is attributable to a couple of
17	important items on the draft five-year strategic plan,
18	the most important of which for budgetary purposes are
19	the proposed national civil rights conference, which
20	is part of the strategic objective dealing with
21	developing the national dialogue on civil rights. And
22	the second relates to the strategic objective of
23	reinvigorating the state advisory committees.
24	We have included in this budget both a
25	little over \$100,000 for a fairly ambitious national

1 conference on civil rights as well as various 2 increases dealing with regional travel to accommodate 3 state advisory committee meetings and a number of new hires, most of which would relate to regional work in 4 5 the state advisory committees. They would include, for instance, a handful of civil rights analysts as 6 7 well as administrative assistants and others to deal with that work. 8 9 Some of the other important items deal 10 with new software and technology for the agency, accommodating the expanded services that we are now 11 12 receiving from GSA for accounting, replacements for computers and printers. Those are the main areas of 13 14 increase. And I would be happy to discuss any of 15 16 them in greater detail. And, of course, we have 17 anticipated cost-of-living increases other and inflation that is also measured in. 18 19 CHAIRMAN REYNOLDS: Okay. At this point 20 is there a motion to approve submission of an \$11 21 million fiscal year 2009 budget estimate to the Office of Management and Budget? 22 23 COMMISSIONER KIRSANOW: So Kirsanow. moved. 24 25 CHAIRMAN REYNOLDS: Is there a second? **NEAL R. 2	primarily driven by the strategic plan, which is why
3	we didn't put that in in the first place, but I don't
4	see why it would hurt to ask.
5	CHAIRMAN REYNOLDS: How much time would it
6	take? I'm assuming that turning the document around
7	wouldn't take long.
8	STAFF DIRECTOR MARCUS: No. I think if
9	the Commission were to approve the budget with
10	additional funds for hiring of eight special
11	assistants, we could fairly easily add that. It would
12	not create any additional time problems.

5	any other comments about the budget?
6	COMMISSIONER MELENDEZ: Yes. Commissioner
7	Melendez here. As far as the travel compared for the
8	regions, we only had for 2008 about 15,000. So has it
9	been increased for the 2009?
10	STAFF DIRECTOR MARCUS: I'm sorry.
11	Commissioner Melendez, are you asking whether the
12	travel for the region has been increased?
13	COMMISSIONER MELENDEZ: Yes.

1 chartered state advisory committees by 2009. 2 Certainly we have a lot more now than we had a year 3 ago, and we certainly hope to continue at this pace. So this is an ambitious travel number which is based 4 5 on the hope and expectation that we will have a large number of active state advisory committees. 6 7 COMMISSIONER MELENDEZ: Okay. As far as the Office of General Counsel, we have a decrease in 8 9 that position over 2008? 10 STAFF DIRECTOR MARCUS: Yes, it is а decrease in that there is one attorney who has left 11 12 the office. And as between an attorney and a senior Office of General Counsel 13 secretary, the has identified an experienced secretary as being their 14 15 greatest single need. And so it reflects having a 16 secretary, rather than an attorney, which is 17 significant savings, which we can use for other purposes that are in the budget. 18 19 COMMISSIONER MELENDEZ: Okay. Based on 20 the fact that the General Counsel is in charge of the 21 statutory reports, by not rehiring an attorney in this position, does that make it more difficult for us to 22 23 fulfill our obligations? 1 First, the General Counsel is not typically 2 responsible for the statutory reports. That responsibility is usually that of the Office of Civil 3 4 Rights Evaluation.

5 This year was an exception in that the Office of General Counsel was primarily responsible 6 7 with only some support from OCRE. Next year is also something of an exception in the sense that the 8 9 prisons project will be shared between those two offices. 10

Part of the reason for this, of course, is that it is taking a little more time than initially anticipated to fill the directorship of the Office of Civil Rights Evaluation.

15 Ι would anticipate that by 2009, the 16 primary responsibility for the statutory report would 17 return to the Office of Civil Rights Evaluation. As you might recall, the statutory report for that year 18 19 deals with fair housing, which is a kind of report which is a little closer to the statutory reports 20 21 traditionally conducted by OCRE.

Now, having said that, there's no question that it would be more difficult for OGC to conduct its work in 2009 relative to a period, say, a couple or a few years ago because it involves a dwindling staff.
