15 1 CHAIRMAN REYNOLDS: This month marks the 43<sup>rd</sup> anniversary of the signing of the Voting Rights 2 3 Act. The Act was signed into law by President Lyndon 4 Johnson on August 6, 1965. The Voting Rights Act 5 suspended literacy, knowledge, and character tests 6 designed to keep blacks from voting in the south. It 7 also authorized the appointment of federal voting examiners and barred discriminatory poll taxes. Today 8 9 we recognize the impact of this important law. 10 I also want to acknowledge that President 11 George W. Bush issues a Proclamation declaring July 26<sup>th</sup> as the day in celebration of the 18<sup>th</sup> anniversary 12 of the Americans With Disabilities Act, which ended 13 14 discrimination against the disabled in employment, 15 public services, accommodations, and 26, 1990, President 16 telecommunications. On July 17 George H.W. Bush signed this comprehensive Act into 18 law. The ADA better enables citizens with 19 disabilities to participate fully in all aspects of 20 On this anniversary, we celebrate the vital life. 21 contributions of individuals with disabilities, and 22 the role the ADA has played in ensuring their full and 23 equal participation in the workplace and elsewhere. 24 have the Staff Director's Next up we 25 Report.

1

2 temporary delay After а due to negotiations with OMB, we are preparing to send our FY 3 2009 budget proposal to Congress. All of the budget 4 5 proposals approved by Commissioners at the July 11<sup>th</sup> meeting remain intact, although some language, and a 6 7 charts that were previously couple of in there received an objection from OMB. 8

9 In the Office of General Counsel, the 10 Commission received notice that the Agency was 11 successful in its defense of a contract appeal action, and OGC has also continued to work on a Merit System 12 13 Protection Board claim, including preparation of 14 several motions and pleadings.

15 In the area of complaints processing, between June 23<sup>rd</sup> and July 18<sup>th</sup>, the Office of Civil 16 17 Evaluation received and processed 178 Rights 18 complaints. And in the area of technology, last month 19 the Agency's email server crashed due to building 20 the Agency's limited backup power outages, and 21 capability. Therefore, I have authorized the purchase 22 of a new backup system with surplus funds from the FY 2008 budget. 23

24Regarding performance management, on25August 8th managers and supervisors submitted

3 In the area of the Statutory Report, some 4 of this will be subject, potentially, to change during 5 the discussion I imagine that comes up shortly, but Commissioners received a revised draft of the FY 2008 6 7 Statutory Enforcement Report enforcing prohibitions of religious discrimination in prisons on August 8<sup>th</sup>. 8 There was a request for comments on the draft to be 9 submitted by August  $22^{nd}$ , and that it would then be 10 11 sent back out to Commissioners on August 29<sup>th</sup>. The draft has undergone the required reviews. 12 And I've 13 also, due to the concerns about some legal and policy 14 issues in the report, I have asked Ken Marcus, our 15 former Staff Director, who's also an expert on 16 religious liberty to provide us with some assistance 17 on the legal and policy review of the document, 18 provide some feedback to us on how -- to make sure we're saying things that are accurate. And, perhaps, 19 20 how that can be improved.

1 still need a fair amount of work, so I was just 2 wondering whether other Commissioners are interested 3 in commenting at this time. 4 CHAIRMAN REYNOLDS: Commissioner Heriot. 5 COMMISSIONER HERIOT: Ι agree with 6 Commissioner Gaziano that the legal background section

7 needs quite a bit of work. And I think the direction we ought to go in is to make it very, very short, 8 9 simply state what statutes, like RIFRA and RLUIPA, 10 I also would put require. in а very brief 11 description, mainly a quote from the Prison Litigation Reform Act, because I think that that bears a lot, in 12 13 my opinion, on why RIFRA and RLUIPA are working 14 reasonably well, why we don't see the floodgates of 15 litigation opening thus far. So that's what I would 16 do, I would leave out the constitutional treatment 17 entirely, very controversial from what I know of this 18 area of law.

I would say it's pretty much as subtle and difficult as any area of constitutional law you are ever going to run across. If you were to take the top ten experts in this area, they wouldn't agree with each other, and we don't have to weigh in on issues like that. There's no particular reason, nothing from our standpoint turns on this, so I would very much

1	like to see the section on the law tamped down to a
2	minimum.
3	As for the rest of it, I think that there
4	is information in here that would be useful to
5	Congress, useful to policy makers. I wish there were
6	more such information. There's still a fair amount of
7	sloppiness in these sections. For example, let me
8	see, one of the tables in here that was identified as
9	"Comparison of Religious Affiliations of United States
10	Adult Population to Inmates in Federal Prisons."
11	If you look down further on the page, you
12	find that it's not inmates in federal prisons, but
13	rather federal inmates engaged in faith-based
14	activities in prison, which is a subset of the federal
15	prisoners. And there's a big difference there. The
16	federal prisoners themselves, collectively, may have a
17	very different religious demography here. So I think
18	that we need a lot of work here.
19	I think that the current findings and

We haven't received anything having to 2 do with the 2010 budget, as far as I know, and it's already August. 3 And if you're talking about doing 4 something before the September briefing, I don't think 5 that's going to be enough time, unless you try to do a business meeting along the list of briefing. 6 And I 7 don't really like to do budgets over the phone. Ι hope that we can do it face to face, have the 8 documents in front of us. 9

10 CHAIRMAN REYNOLDS: That's a good point. 11 Commissioner Melendez makes a good point. 7	authority of the Acting Deputy Staff Director."

1	DISCUSSION OF SAC RE-CHARTER PROCESS
2	CHAIRMAN REYNOLDS: At the July $28^{th}$
3	during the July 28 <sup>th</sup> teleconference, some concerns were
4	raised about staff implementation of the Lean Six
5	Sigma re-chartering process that the Commission voted
6	to adopt, that the Commission adopted, rather, in
7	January of 2008.
8	On August $14^{th}$ , the Staff Director sent a
9	memorandum to Commissioners detailing how the Lean Six
10	Sigma process has been applied to the re-chartering of
11	State Advisory Committees. Mr. Staff Director, do you
12	have any additional information for us?
13	STAFF DIRECTOR DANNENFELSER: Thank you
14	again, Mr. Chairman.
15	Yes, as you noted in the memorandum that I
16	did send to the Commissioners, many of the SACs that
17	were re-chartered were well in process by the point
18	that we adopted the Lean Six Sigma process. And the
19	other cases, the regional offices have kept to the
20	critical to quality parameters that Booz Allen
21	identified. And we are sending out directives to the
22	regional directors; in fact, I mentioned in there that
23	I sent a memorandum to them on August $8^{th}$ to formalize
24	this process, so to make sure that they are following
25	the various checklists that were developed. And we

1 are going to institute with myself and the regional 2 coordinating unit chief, qoinq programs we're to 3 institute monthly meetings with each one of the 4 regional directors to go through where they are with 5 every state, and also to reinforce the point of Lean 6 So I don't suggest that the process has Six Sigma. 7 been followed perfectly in the past, but I think in most cases, that regional directors have applied the 8 process, and we are going to, based on these concerns 9 10 of the Commissioners, to more vigorously oversee this process with the regional directors to make sure that 11 12 it's applied in the future. CHAIRMAN REYNOLDS: Does this involve the 13 14 use of checklists? And do we have checklists they're

15 to use to make sure that we have jumped through the 16 proper hoops? And is that submitted to the Office of 17 the Staff Director by regions? I mean, how do we --18 what's our quality control like? How do we ensure that since we're rolling out this process, and since 19 with any new process there are going to be bumps along 20 the way, how are we checking up to make sure that 21 22 people are implementing Lean Six Sigma properly?

23 STAFF DIRECTOR DANNENFELSER: Well, we're 24 going to require that whenever any new package comes 25 in to us, that it will contain the three checklists
