But in addition to that, I would like to note for the record that on Thursday, September 13th, 2007 the United Nations General Assembly overwhelming approved the first Declaration on the Rights of Indigenous Peoples. Among the many rights described in the document the Declaration affirms the rights of all indigenous peoples to self-determination and to preservation of their integrity as a distinct peoples.

9 I'm sad that the United States was one of 10 just four countries to vote against the Declaration. 11 But pleased that over 140 countries voted for the 12 measure.

The adoption of the Declaration is a historic event that has been decades in the making. I am proud to see the world community take a stand to ensure minimum standards for the survival, dignity and well-being of all indigenous peoples.

And I understand the Justice Department is 11 12 currently monitoring the situation. The facts are developing and are somewhat disjointing and sparse. 13 It is nonetheless it just strikes me as something that 14is clearly within our purview and I would request that 15 Staff Director instruct appropriate staff to at least 16 monitor the situation, apprise us of developments and 17 maybe it will be placed on a future agenda item as 18 19 events may warrant.

VICE CHAIR THERNSTROM: 20 I don't have any problem with that. As you say, the factual record 21 here needs a great deal of flushing out. There are in 22 my view some very basic questions, factual questions, 23 still unanswered. And given the amount of commentary 24 25 floating floating around the blogs, around the
