# Appendix G. Scoping

# G.1 Introduction

The Clark County Department of Aviation (CCDOA) requested input on the scope of the analyses to be conducted for the Environmental Assessment (EA) for a Southern Nevada Regional Heliport (the Heliport) by hosting a public scoping meeting, an agency scoping meeting, a 30-day scoping period, an Open House for the Seven Hills/Westgate Westgate and Anthem areas. When an additional build alternative was added to the EA, the CCDOA notified agencies and interested parties of the addition and hosted a second 30-day comment period. Additionally, the CCDOA maintained a website of information pertaining to this outreach at <u>http://www.ricondoprojects.com/heliport/</u>, and provided a contact name, phone number and address for questions and concerns relating to the preparation of the EA.

# G.2 Scoping Meetings and Notices of Intent

The CCDOA held a scoping meeting to accept comments on conditions, studies, plans, or considerations that may be relevant to determining the potential environmental consequences of the proposed action or its alternatives.

An agency scoping meeting was held in the County Commission Chambers at 1:30 p.m. on Monday June 28, 2004, to solicit comments from agencies with regulatory authority of the construction and operation of the Proposed Action. A notice of intent to hold an agency scoping meeting was sent to multiple federal and state agencies and is included as **Attachment G-1**.

The public scoping meeting was on Monday, June 28, 2004, at 6:00 p.m. in the County Commission Chambers, 500 S. Grand Central Parkway, Las Vegas, Nevada. A notice of intent to hold this public scoping meeting was sent to interested parties and is included as **Attachment G-2**. The public scoping meeting was advertised in the Las Vegas Review Journal on June 13, 20, and 27, 2004. This notification is included as **Attachment G-3**. The affidavit of publication is included as **Attachment G-4**.

Additionally, an Open House for the Seven Hills/Westgate and Anthem areas was held on Thursday, July 15th 2004, at 6:30 p.m. at Elise L. Wolff Elementary School, 1001 Seven Hills Drive, Henderson, Nevada. The Open House addressed issues related to the Southern Nevada Regional Heliport and the environmental review process. The Open House notice is included as **Attachment G-5**.

Originally, the CCDOA identified four build alternatives in addition to the Proposed Action, as well as a No Action alternative in which commercial helicopter operations would remain based at McCarran International Airport. In October 2004, the Sunrise Landfill site, a fifth build alternative, was added to the scope of this EA, for a total of seven alternatives. A public meeting regarding the addition of the Sunrise Landfill alternative site was held with the Sunrise Manor Town Advisory Board on Thursday, December 2, 2004, at 7:00 p.m., Hollywood Recreation and Community Center, 1650 S. Hollywood, Las Vegas, Nevada 89110. Comments were to be sent to the CCDOA by Friday, December 17, 2004. A notice of intent to add the Sunrise Landfill alternative site to the EA was sent to interested parties and is included as **Attachment G-6**. A notice of intent to add the Sunrise Landfill alternative site to the EA was sent to agencies and is included as **Attachment G-7**.

## G.3 Scoping Comments Summaries

As discussed in Section G.1, federal and State agencies, interested parties, and individuals were informed of the preparation of an EA for a Southern Nevada Regional Heliport, the subsequent addition of an alternative to the EA, the scoping meetings, and the comment periods. Through the scoping process, the CCDOA requested input as to the extent and type of environmental analyses that could be accomplished in the environmental study for this project.

### G.3.1 Comments Received on the Site Suitability Study

In addition to anticipated scoping comments, the CCDOA considered all comments received on the Site Suitability Assessment to be indicative of the public's concerns relative to a new non-urban heliport. These 946 comments were reviewed as though they were scoping comments in order to determine issues that could be appropriately addressed in this EA. A summary of this review is included as **Exhibit G-1**.


### G.3.2 Comments Received during Scoping Period


The initial scoping period closed Monday, August 2, 2004. One hundred and twelve (112) comments were received by this date, and are summarized in **Exhibit G-2**.







