ANOTHER MAJOR PROBLEM IS MANY OF THE INSPECTORS ARE NOT QUALIFIED ENOUGH OR TRAINED ENOUGH TO IDENTIFY A TRULY UNSAFE SITUATION--INSTEAD KNIT-PICK THINGS OR MINOR INFRACTIONS ARE REGARDED AS LIFE THREATENING CAUSING CITATIONS, FINES, POINTS AND PENALTIES ARE BEING ISSUED AND ASSESSED. THIS IS COSTLY, BECAUSE FINES ARE BASED ON POINTS ISSUED!!
