Dear Governor Whitman:

Rural communities in Texas are faced with many challenges as they strive to prosper in difficult economic times. I recently heard from representatives of the Hickory Underground Water Conservation District (UWCD) No. I about concerns with new Environmental Protection Agency (EPA) drinking water regulations. Because of naturally occurring levels of radionuclides in this area's groundwater, the new regulations may, qiiire simply, make drinking water too expensive for the residents of San Saba, Menard, Concho, Mason and McCullough counties.

The Hickory UWCD No 1 reports that the Texas Department of Health has encountered no cases of bone cancer (the most significant health risk from rsdionuclides) in the region where residents obtain their drinking water from the Hickory Aquifer. Before these regulations are imposed on our rural citizens, we must be certain that the regulations are indeed scientifically justified and provide a real public benefit. I ask that in enforcing these new regulations you take into account the lingering scientific uncertainty and the economic impact upon the residents of this largely rural agricultural area. I am also aware that these regulations are the subject of pending litigation brought by community water suppliers located in several states, providing an additional reason for staying borh the enforcement of the rules and rhe requirement that stare programs proceed with rulemakings to implement the contested federal program. Regulations that essentially farce long-tume residents to move from their homes will devastate numerous rural communities across die entire country and will not achieve the goals set by the U.S. Congress.

Thank you for considering the impact of these regulations on Texas agricultural communities.
