### Area Schools Compete in DOE's National Science Bowl<sup>®</sup> America's Future Scientists and Engineers Show What They Know

AIKEN, S.C., (February 4) –America's next generation of scientists and engineers will soon put their knowledge to the test in the country's largest science tournament. The Department of Energy's (DOE) National Science Bowl<sup>®</sup> involves more than 17,000 students competing in regional events held in 41 states, Puerto Rico and the U.S. Virgin Islands.

Each match will put students' knowledge to the test in science and math using a fast-paced question and answer format similar to *Jeopardy*. DOE's National Science Bowl is the only educational event and academic competition of its kind that is sponsored by a federal agency.

"Developing the students who will be our next generation of scientists and engineers is critically important," said Jeff Allison, Manager, Department of Energy-Savannah River Operations Office. "In many ways, the economic success of our nation's future lies in their hands."

DOE's National Science Bowl for high school students features 67 regional competitions, each one sending a winning team to the National Finals (all-expenses-paid trip), scheduled for May 1-6, in Washington, DC.

The national championship team will win its choice of three science-related trips, which include locations in the U.S., France and England.

Ten CSRA high schools will compete against 13 other teams from South Carolina in the 18<sup>th</sup> annual Department of Energy Regional Science Bowl at The University of South Carolina Aiken Saturday, Feb. 9. Competition begins at 9 a.m. at USC Aiken's Business and Education Building.

Aiken High School, Aquinas High School, Augusta Area Homeschoolers, Augusta Preparatory Day School, Davidson Fine Arts Magnet School, Fox Creek High School, Lakeside High School, North Augusta High School and South Aiken High School are the local contestants.

Since DOE's National Science Bowl began in 1991, more than 130,000 students – and their teachers – have participated. Student teams, which consist of four students, an alternate, and a teacher/coach, practice for months before the competition. Many teams even test their knowledge against real scientists at major corporations or DOE's National Laboratories, who volunteer their time to help students prepare to answer complex questions.

The competition's questions are so complex that they often stump professional scientists. For example:

- *Physics* Assuming g + 10 meters per/sec<sup>2</sup>, if a pulley is used to lift a 1 Kg weight 2 meters high, how much work in SI units was expended to overcome friction if 20 Newtons of effort was used? Answer: 20 Joules
- General Science This fungues is the causative agent for what was known in medieval times as St. Anthony's fire and is now used as a source for certain drugs. Answer: Ergot



# **Directions to USC Aiken**

## Traveling I-20 East:

Exit I-20 at Exit 18/Highway 19. Turn right onto Highway 19. Go 4.2 miles. Turn right onto Highway 118 and go 3.1 miles. Turn left onto University Parkway. Go through the traffic light. USC Aiken will be on your right.

## Traveling I-20 West:

Exit I-20 at Exit 22/Highway 1. Turn left onto Highway 1. Go 8.0 miles. Turn right onto Richland Avenue/Highways 78/1. Go 2.8 miles (passing through the downtown business district). Turn right onto University Parkway. Go .6 miles. USC Aiken will be on your left.
