Children's Health Insurance Program Reauthorization Act of 2009: The House passed H.R. 2, to amend title XXI of the Social Security Act to extend and improve the Children's Health Insurance Program, by a recorded vote of 289 ayes to 139 noes, Roll No. 16. **Pages H216–68**

Rejected the Deal (GA) motion to recommit the bill to the Committee on Energy and Commerce with instructions to report the same back to the House forthwith with an amendment, by a yea-and-nay vote of 179 yeas to 247 nays, Roll No. 15. **Pages H264–67**

H. Res. 52, the rule providing for consideration of the bill, was agreed to by a recorded vote of 244 ayes to 178 noes, Roll No. 14, after agreeing without objection to order the previous question. **Pages H203–16**

Suspensions: The House agreed to suspend the rules and agree to the following measure:

Amending the Rules of the House of Representatives to require each standing committee to hold periodic hearings on the topic of waste, fraud, abuse, or mismanagement in Government programs which that committee may authorize: H. Res. 40, amended, to amend the Rules of the House of Representatives to require each standing committee to hold periodic hearings on the topic of waste, fraud, abuse, or mismanagement in Government programs which that committee may authorize, by a $\frac{2}{3}$ ye-a-and-nay vote of 423 yeas with none voting “nay”, Roll No. 18. **Pages H268–73, H281**

TARP Reform and Accountability Act of 2009: The House began consideration of H.R. 384, to reform the Troubled Assets Relief Program of the Secretary of the Treasury and ensure accountability under such Program. Further proceedings were postponed. **Pages H282–90, H290–99**

H. Res. 53, the rule providing for consideration of the bill, was agreed to by a ye-a-and-nay vote of 235 yeas to 191 nays, Roll No. 17, after agreeing without objection to order the previous question.

TARP REFORM AND ACCOUNTABILITY ACT OF 2009

Committee on Rules: Granted, by a non-record vote, a rule providing for further consideration of H.R. 384, the TARP Reform and Accountability Act of 2009, under a structured rule. No further general debate

shall be in order. The rule provides that the bill shall be considered as read. The rule waives all points of order against provisions in the bill.

The rule makes in order only those amendments printed in the report of the Committee on Rules. The amendments made in order may be offered only in the order printed in the Committee report, may be offered only by a Member designated in the Rules Committee report, shall be considered as read, shall be debatable for the time specified in the Committee report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment, and shall not be subject to a demand for a division of the question in the House or in the Committee of the Whole. All points of order against the amendments except for clauses 9 and 10 of rule XXI are waived. The rule provides one motion to recommit with or without instructions. The rule provides a motion to proceed under section 115 of the Emergency Economic Stabilization Act if offered by the Majority Leader or his designee which may be offered not later than the legislative day of January 22, 2009. Testimony was heard from Representatives Speier, Jackson-Lee (TX), Kaptur, Corrine Brown (FL), Hinchey, Kennedy, Welch, Neugebauer, Gohmert, Dent, and Bilirakis.
