County and Municipal POLICE Promotional Schedule (2008)

This alert is intended to notify appointing authorities and police promotional candidates of the timeframes that will apply to the N.J. Department of Personnel's 2008 announcement and testing schedule for in-line, police promotional titles. Providing these dates in advance, hopefully, will assist appointing authorities and potential promotional candidates with their respective planning needs. Candidates may also go to the Department of Personnel's website (www.state.nj.us/personnel) when an announcement is issued to obtain an orientation guide which will include the specific test date that corresponds to their promotional announcement.

As the above schedule reveals, the N.J. Department of Personnel (DOP) issues announcements annually for the titles of Police Sergeant, Lieutenant and Captain, and semi-annually for the titles of Inspector, Deputy Chief and Chief. Please note that DOP will <u>automatically</u> initiate Sergeant, Lieutenant and Captain announcements for most jurisdictions based on the expiration date of an existing list for a given municipality. <u>However</u>, if a promotional list is exhausted or is expected to be exhausted or rendered incomplete prior to its expiration date, an Appointing Authority should initiate a new announcement and submit its request by the appropriate deadline indicated above.
