

The National Reading First Data Profile provides a national look at Reading First funding and subgrantee data for the 50 states and for 4 jurisdictions — American Samoa, Bureau of Indian Affairs, District of Columbia, and the Virgin Islands. The National profile reports aggregate state and district funding data by year, and aggregate subgrantee and student data by school year. The funding data section shows the aggregate Federal funding awards made to the 54 states/jurisdictions, and estimated aggregate funding amounts retained by the states/jurisdictions and outlayed to their districts, from year 1 of the award through 2006. The subgrantee and student data section is limited to the year 2005, which is the last year for which school data are currently available. Reading First awards were made to 21 states and jurisdictions in 2002; 32 in 2003; and to 1 in 2004.
