Collections News

"Save America's Treasures" Project Update

The State Archives' major project to conserve over 5,200 leaves of Revolutionary War manuscripts is now in its third year. The Conservation Center for Art and Historic Artifacts in Philadelphia, the contracted conservator for the work, has treated several collections—some of which were microfilmed or re-filmed by the State Archives as part of the process. Specifically, the following record series (or portions of them) have been returned to the Archives and are now available for research:

- Moore Furman / Correspondence, 1776-1785 [loose material only]
- Salem County / Court of Common Pleas / Executions to Sell Real Estate of Loyalists, 1778-1779
- Essex County / Court of General Quarter Sessions of the Peace / Shopkeepers' Petitions and Licenses, 1781
- Middlesex County / Petitions for Shopkeepers' Licenses, 1781
- Bureau of Archives and History Manuscript Collection Court of Oyer & Terminer records, 1775-1783
- Bureau of Archives and History Manuscript Collection Militia Papers, 1775-1785

State Archives Collection Manager Ellen Callahan oversees the project, with support from archivists Janet Jackson and Vivian Thiele. Black Family Papers Accession

In June 2006, William T. Black Jr. donated an incredible treasure of family papers, maps, and Burlington County tax and militia records to the New Jersey State Archives. This cache of manuscripts, spanning three centuries, was preserved and passed down through the generations of the Black and Newbold families, prominent early settlers of Chesterfield Township and vicinity. Mr. Black's generous and public-minded gift will ensure the long-term preservation of this remarkable collection and at the same time make the documents accessible to the many thousands of researchers who use the State Archives each year.

The donation includes parchment indentures and estate papers from 1684-1845, business ledgers from 1776-1904, official records of Burlington County Tax Collector John Black from 1781-1813, a small collection of militia papers from 1797-1804, and maps and drawings from as early as 1780. The State Archives frequently redirects potential donations of family papers to other repositories. However, in this case, the collection included important 18th- and early-19th-century government papers and numerous colonial-period land records. Among the taxation records, for example, are several hitherto unknown Burlington County tax ratable lists from the late 1700s. Given the nature of the material and how it relates to records already in the State Archives, accepting the collection was an easy decision.

Janet Jackson, under the supervision of Ellen Callahan, is describing the collection in detail and arranging the documents in archival housings—a process begun by Mr. Black prior to donation. A preliminary inventory is available in the State Archives' Manuscript Reading Room.

Preservation Microfilming

The State Archives is actively microfilming manuscript collections to preserve them and make them more readily accessible to the public. 1895 Census Available Online

In November 2007, the State Archives allowed The Generations Network to post images of the 1895 New Jersey State Census—created from microfilm of originals owned by the State—to its well-known website, www.ancestry.com. While the images are not currently of optimal quality and the index is, consequently, incomplete for certain unreadable sections, the release of this data nevertheless will be an important boost for genealogists looking for families in 1895 for most areas of the state. State Archives management and representatives of The Generations Network are working together to find ways to improve these census images online and complete the indexing.

Website News

Online Databases

Since our last *eNews*, State Archives staff and management have invested much time and effort to improve online access to our databases. We are very pleased to announce that a far more powerful search engine has been developed for the three databases previously posted to our site: New Jersey Marriages, 1848-1867; New Jersey Marriages, 1666-1799; and Supreme Court Case Files, 1704-1844. State Archives website users can now enjoy much faster searches and can also sort the results by field (e.g., by place or date in addition to name). Reaching this milestone now allows us to focus our efforts on posting <u>new data</u> to our site. We anticipate that during the upcoming months we will unveil online access to databases indexing:

- Passaic County and Atlantic City portions of the 1885 State Census (completed by volunteers)
- New Jersey's Civil War vouchers (documenting soldiers' pay and discharges, subsistence paid to wives and widowed mothers, payments to surviving relatives, etc.)
- Name-change judgments (statewide), 1847-1947
- East Jersey Proprietors' surveys, late 1600s-20th-c.

We would like to publicly acknowledge the ingenuity and perseverance of Archivist Vivian Thiele in the development of our improved search engine. Vivian went far beyond the call of duty as an archivist to train herself in the programming and IT skills required to get this job done. We also acknowledge John Flood of the State's Office of Information Technology for his instrumentality and cooperation.

Documentary Treasures

We have expanded our "Documentary Treasures" site extensively since our last *eNews*. We added a new area celebrating New Jersey's original federal charters, which were digitally scanned in August 2006. This includes New Jersey's ratification of the United States Constitution and its original Bill of Rights. In addition, we've added the full minutes of the State's 1787 ratification convention and the legislative actions (ratification or otherwise) relative to the 27 federal constitutional amendments. In all, the added material comprises 170 new web-pages of images, transcriptions and constitutional history.
