# "Save America's Treasures" Update

The State Archives' four-year Save America's Treasures (SAT) project to preserve New Jersey's most important Revolutionary War-era documents reached the "home-stretch" in June when staff sent the seventh and final shipment of manuscripts to the Conservation Center for Art and Historic Artifacts (CCAHA) for treatment. The final cache of documents included records of seized property and forfeited estates of Loyalists who served with or supported the British during the Revolution. Due to reach completion by the end of 2008, the SAT project is funded through a 2004 joint grant from the National Endowment for the Humanities and the National Parks Service.

# Preservation Planning

Earlier this year, the Institute for Museum and Library Services (IMLS) announced the award of \$40,000 to five partner institutions for preservation planning in New Jersey. The consortium includes the State Archives, the State Museum, Newark Museum, Rutgers University Libraries, and the State Library. The project will entail development of a statewide plan for over 600 museums and historical societies, 400 libraries and 80 archives. In addition to the tier-one partners, the planning will also involve advisors from many other cultural and professional organizations, to produce representation from all sizes and disciplines of museums, libraries, and archives. In light of the IMLS grant, the State Archives, through the New Jersey State Historical Records Advisory Board (NJSHRAB), applied for and received related funding from the National Historical Publications and Records Commission (NHPRC) through its State and National Archival Partnerships (SNAP) grant program. This award of \$56,652, announced in June, include funds for the administration of the NJSHRAB but also nearly doubles available funding for the analysis of conservation needs in New Jersey—in particular, a more in-depth study of the hundreds of needs assessments for local (county and municipal) records produced by the Public Archives and Records Infrastructure Support (PARIS) grant program administered by the Division of Archives and Records Management. The goals of the joint planning effort include: to determine the advisability of establishing a conservation center in New Jersey, to develop models for disaster planning and emergency response, and to explore opportunities for shared archival and museum storage.

# 1849 Railroad Map Comes Home

The State Archives recovered a long-missing filed map of the right-of-way of the Belvidere Delaware Railroad in March. The exquisite map appears to have been loaned by the Secretary of State's Office to the Department of Transportation some time in the early- to mid-20<sup>th</sup> century, and was missing at the time of accessioning of this collection by the State Archives. DOT officials recently contracted for conservation treatment of the map in Philadelphia, which led to its return instead to the State Archives, where it has been reunited as a filing of the Secretary of State's Map Collection. Completed in 1855, the Belvidere Delaware Railroad was a subsidiary of the Pennsylvania Railroad, running parallel to the Delaware River from Trenton to Belvidere in Warren County. Measuring approximately three by nine feet, the intricate route survey includes names of all contemporary land owners as well as locations and names of islands in the Delaware.

# **Proprietary Records**

Thanks to a grant from the New Jersey Society of Colonial Wars announced in December 2007, five of the most significant documents from the ancient proprietary records of the Province of West New Jersey are now being treated by the Conservation Center for Art and Historic Artifacts in Philadelphia (CCAHA). Of special significance are the 1664 lease and release of James, Duke of York, to John, Lord Berkeley and Sir George Carteret—together, the "birth certificate" of the English colony.

In April, another collection of proprietary-period treasures returned to the State Archives following treatment at CCAHA. This was the 1684 *Record Book of Robert Barclay, Proprietary Governor of East New Jersey*. The most significant item acquired by the Archives at Christie's in June 2005, the Barclay volume contains transcriptions of original land grants, legal cases, correspondence with officials including William Penn, and a record of the proceedings of Lords Proprietors during 1682-84.

# Intern Projects

Chris Mazur, a Rider University history/education major, and Dana Treichler, a senior at Hightstown High School, interned under the supervision of Collection Manager Ellen Callahan this summer. Mr. Mazur's projects included organizing Works Projects Administration (WPA) records from the late 1930s which contain benchmark inventories of early colonial and state records. He also processed miscellaneous records of the East Jersey Proprietors, including a newly discovered cache of Revolutionary War-era accounts and receipts relating to an East Jersey account book held by the Library of Congress, a microfilm copy of which is available at the Archives.

Ms. Treichler produced the database that will be used to create a guide to the WPA inventories of material once stored in the State House. She also sorted collections of Hudson County Court of Common Pleas and Court of Oyer and Terminar case files.

#### In-House Access to Collections

The State Archives has begun using a Microsoft Access-based database system developed by Archivist Vivian Thiele as its accessioning and cataloging management tool. The new system, as it is refined, will provide more robust ways to accession, inventory and catalog material, and will eventually provide a searchable catalog on the Archives' website. The new system will ultimately replace the venerable dBASE system known as ARMADA, created by Chief of Archives Joseph Klett nearly two decades ago, adapted for the move of the State Archives in 2000, and further developed to produce the Archives' browseable website catalog in 2003.

The State Archives has also recently acquired in new version of ISYS software, which is used for keyword searching of collection guides.

## **Website News**

#### New Databases Online

The State Archives has added three new databases to its website since our last issue. The first indexes Passaic County and Atlantic City returns from the 1885 New Jersey State Census. The database was built through the generous contributions of time and data-entry work by volunteers Marie Hook and Nancyann Carkeek. The census can be searched at:

The second database indexes legal name changes filed with the Secretary of State or granted by the Legislature during the period 1847-1947, with a few records from as late as 1964. While this source has significant genealogical value, it will also be of interest to social historians researching the assimilation of immigrant families into American society. The database was created through the diligent work of State Archives' staff member Joanne Nestor. Search the index here: https://www.netl.state.nj.us/DOS/Admin/ArchivesDBPortal/NameChanges.aspx.

The third database indexes inventories of Revolutionary War damages to personal estates by British and American soldiers during 1776-1782. Legislation in 1781 produced the inventories; however, records are not extant for all of the counties. Nevertheless, the collection provides invaluable historical and genealogical data about local and personal losses during the war. Since no claims were apparently ever paid, the survival of this documentation is especially fortuitous. #### Search Room Access to Online Resources

The State Archives negotiated an institutional membership with Ancestry.com, the world's largest online resource for genealogical information, in return for permission to place the State Archives' 1895 New Jersey state census online for the first time. Access to Ancestry was formerly made possible through a subscription to Heritage Quest Online. The latter subscription remains intact, with its available resources (absent the now-redundant Ancestry component of course).

# Tales from the Search Room

Dylan Penningroth of Northwestern University has commenced socio-economic research, using various sources, relative to African-American life from 1865 to the 1930s. Penningroth has undertaken similar research in Washington, D.C. and Virginia, where African Americans also comprised a significant percentage of the general population. Penningroth is using census records to identify Black families and individuals in conjunction with chancery court records to determine whether patterns can be seen in the causes brought before the court and case judgments.

#### 1796 Archives Site Dedicated

In May, Secretary of State Nina Mitchell Wells and Division Director Karl J. Niederer hosted a public unveiling of a historic marker commemorating the rediscovery of the 1796 building erected to house the original archives of the state. Located under the plaza in front of the State House, the foundations of the ancient precursor to today's institution were revealed during 2006 archaeological excavations. The site has been delineated in the plaza with inlaid cut stone of the same kind used in the 1796 construction. An interpretive marker unveiled the history and purpose of the building, and the archaeological findings that led to its authentication. The New Jersey Historic Sites Council and State Historic Preservation Office, Department of Environmental Protection, honored the Department of State with a 2008 New Jersey Historic Preservation Award for the discovery, preservation and commemoration of the site.
