On June 13, 2006, a panel of IRS officials (Michael Julianelle and Joyce Kahn) and two benefits practitioners got together on a Tax Talk Today program and discussed the advantages of fixing mistakes in retirement plans now rather than later. The panel's consensus: The value of preventive maintenance far exceeds the increasing costs of waiting to correct plan mistakes.
