
CHAPTER X

DATA CONCERNING MEN AND MATERIAL
CONNECTED WITH THE OLD CAPITOL

THE organization of the working forces, the division of labor, the responsibility of the different officials, the cost of labor and material, and the dimensions of the Capitol are all a part of its history. When the Government commenced operations, Washington was in existence only on paper—a small number of houses, and without population, except in Georgetown, a village with less than 3,000 inhabitants, about 2 miles from the Capitol. There were none of the facilities for conducting work usual to a city, no machinery, few mechanics or teams, only newly made dirt roads. Portions of the work were let out by contract, but by far the larger part was done by day labor. The quarrying of stone at Aquia Creek was at first done by contract, but afterwards by the Government by day labor. Brick were made in the city. After the fire in 1814 the marble caps for interior work were secured in Italy.

The architects and principal superintendents in the early work came from abroad—one from the West Indies, one from France, and four from England. Only three who had to do with the old Capitol were born in this country—Bulfinch, Lenox, and Mills.

The Presidents of the United States for the first forty years in our history took quite an active interest in the building operations of the Government, and directed the work personally in many instances, all urging a close adherence to the original design and insisting on classic models. Their instructions were carried into operation and details of administration were executed first through the District commissioners until 1802, when their duties in relation to Government buildings were assumed by a superintendent of public buildings until 1815, when

three commissioners were appointed to reconstruct the Federal buildings after the invasion by the British in 1814. They were replaced in 1816 by one commissioner of public buildings. This form of office continued in existence until the commencement of the present wings or Capitol extension, in 1851. The commissioner continued in charge of the central portion of the building until 1867.

Of the architects, clerks of works, and superintendents, it is not necessary to say that their duties were those usual to their positions.¹

¹ The tables in Brown's volumes have been reprinted in this edition with his original footnotes. Brown obtained the data for his tables from a variety of sources, including statutes enacted by Congress establishing the names, salaries, and duties of the principal individuals in charge of the Capitol prior to the design and construction of the Capitol Extension. These laws, listed by Brown in his bibliography as laws governing the office of Commissioner of Public Buildings and Grounds, were passed on the following dates: July 16, 1790; May 6, 1796; April 18, 1798; May 1, 1802; May 27, 1804; February 13, 1815; April 19, 1816; May 15, 1820; March 3, 1823; May 26, 1824; May 2, 1828; March 3, 1829; May 1, 1832; May 2, 1832; March 2, 1833. For the period 1793–1800, Brown also used the various reports on the federal city submitted by the Commissioners of the District of Columbia between 1796 and 1799 and the messages of Thomas Jefferson relative to the affairs of the federal city, dated 1800 to 1803. See also the reports on public buildings made by Charles Bulfinch and Robert Mills between 1800 and 1838, and indexes of accounts located in the Office of the First Auditor, 1790–1838.

The *U.S. Statutes at Large* reprinted both public and private laws enacted by Congress relative to the construction, repair, furniture, lighting, and artwork in the Capitol over the time period covered in the first volume. Treasury Department records also contained records for warrants drawn for payment to certain individuals who worked on the Capitol. Most of the information gathered here was a matter of public record, such as salary information contained in the reports of the Architect of the Capitol.

Many mechanics were secured by advertisement in other cities of this country, while others were obtained through agents in Europe.

From 1793 to 1814 mechanics and laborers worked from 6 to 6; after 1814 mechanics worked ten hours, except short winter days, when they worked from sun to sun, and laborers continued to work

from sun to sun during the whole year until 1840, when they were put upon the ten-hour basis. Wages do not seem to have varied materially until after the war of 1812, when they were about doubled.

Negro mechanics were objectionable to the white mechanics and were only employed once as an experiment.

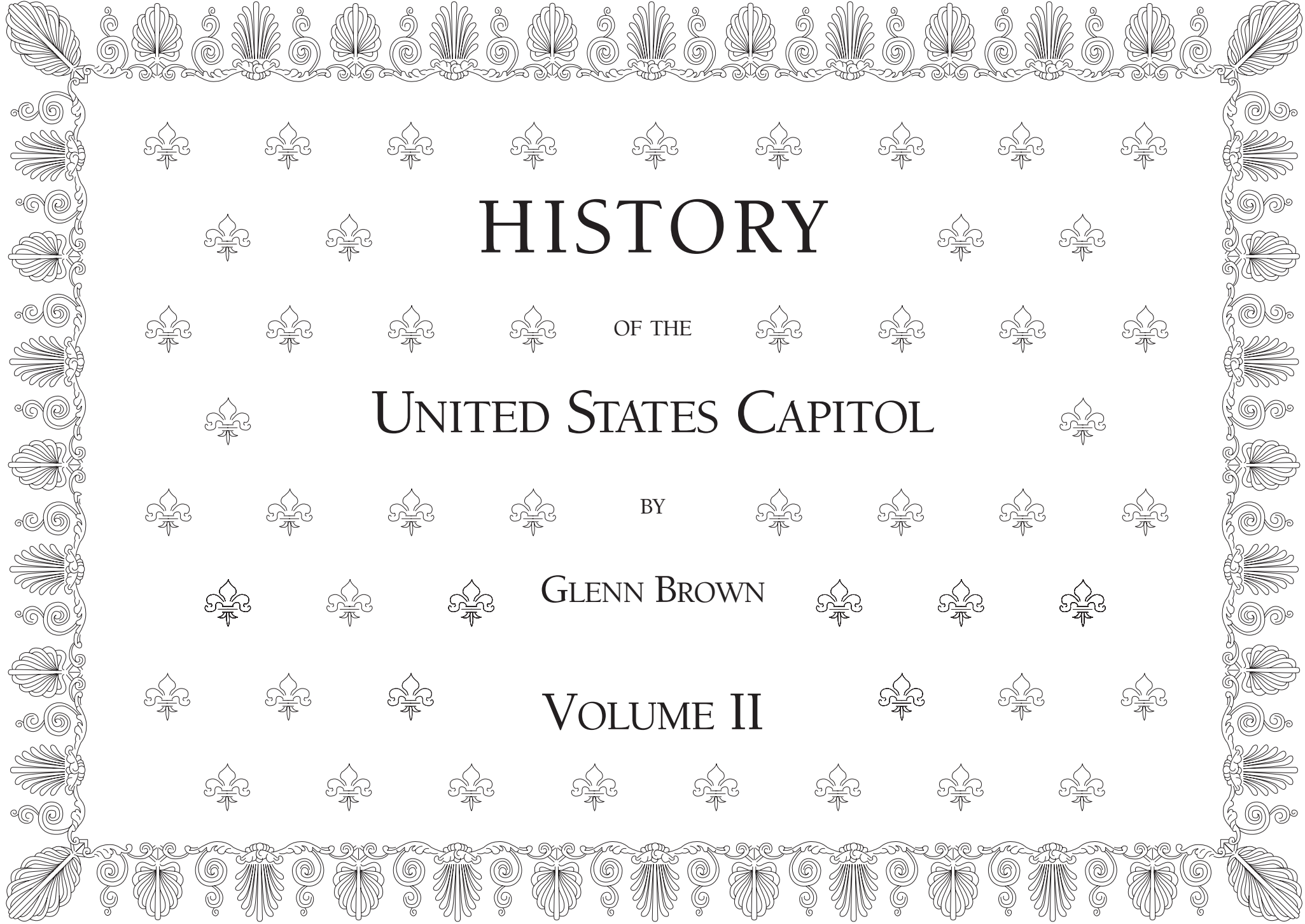
