Re: "TFR Revisions" OMB No. 1550-0023

Gentlemen:

Requiring shorter deadlines on the TFR, CMR and HC reports will create a heavy burden to use accurate numbers and still file on time.

This past year we've been fortunate to get the reports transmitted on the current due date with six separate instances of transmission later than regular business hours.

Even this was only accomplished by staff working evenings and weekend prior to the deadline. Some of the data is not always available on time, causing estimates to be used. If the OTS wants accuracy, then we have to take additional time to recalculate the reports a second time and send an amendment.

Enclosed is our transmission log for the past year. You can see that we've not been able to transmit sooner than one day before the deadline. Of the total sixteen reports due (five each) of the TFR, CMR, HC and one BOS, we've been able to transmit only:

- 4 - 1 day prior to deadline
- 6 - regular business hours on deadline date
- 6 - after business hours on deadline date

one TFR at 8:30 P.M.
one CMR at 6:30 P.M.

Please reconsider your proposal to shorten the filing due date, and allow it to remain as it is.
