


Riverside Federal Records Center to offer Digitization Service

In the coming months, the Production Scanning Team at the Federal Records Center (FRC) in Riverside, CA, will begin offering high-speed, high-quality, high-capacity digital records conversion services to Federal agencies. The FRC is currently training staff, purchasing hardware and software, and adding new office space. As part of a national NARA initiative, we will be undertaking projects of all sizes - from just a few high-use records to hundreds or even thousands of cubic feet of records. Eventually, our digital imaging services will be able to accommodate non-textual records, like 35mm slides and oversize maps and drawings.

The FRC's initial digital imaging services will include:

- Conversion services (paper to digital) for both temporary and permanent records
- Output to formats such as PDF, JPEG, TIFF, XML, and others
- Optical Character Recognition (OCR), Intelligent Character Recognition (ICR), and Optical Mark Recognition (OMR), as requested
- Custom levels of scanning, from basic scanning for administrative copies to premium scanning that meets NARA scanning specifications for permanent electronic records
- Strict quality-control measures, as requested, from a predetermined sample size or up to 100% verification
- Entry of as many metadata items as an agency requests
- Back-up storage for digitized records in the

Forest Service Regional Historical Documents Come to NARA San Bruno

In late August, 2008, the Regional Archives in San Bruno acquired an important Forest Service archives collected over a period of nearly 25 years by the agency's Pacific Southwest Region, which covers the state of California. The collection was begun by Donald S. Miller, head of the regional cultural resources program, and built since 1986 by his successor, regional historian Linda Lux. Lux, who retired September 3, had continued to preserve, catalog, and provide reference for the collection until it reached nearly 100 cubic feet in volume. Researchers at the NARA regional archives will now have access to more than 4,000 individually cataloged documents, reports, speeches, and publications related to the full range of Forest Service subjects and issues, such as conservation and preservation, fire management, forest planning, timber management, research, and recreation, to name a few. Records are described in a database searchable by author, date, subject, and other fields.

new FRC Electronic Records Units (ERUs)

All necessary document preparation, including removal of staples, paper clips, and binders.

Nothing will be outsourced or subcontracted. All scanning will be done by Federal employees at the Riverside FRC, with the paper records staying onsite under NARA's control.

Nationwide, only four FRCs - Ft. Worth, Atlanta, St. Louis, and Riverside - offer this digital conversion service at this time. However, Federal agencies from any region can use this service. Agencies that do not store their records in an FRC may still use the FRC document conversion services by shipping their records to a participating location. As an added service, the Riverside FRC offers storage of backup copies of an agency's newly created digital files.

Forest Service Honors NARA Staff

The US Department of Agriculture, on behalf of the Forest Service, has given an Extra Effort Group Award to NARA employees Patti Bailey, Richard Boyden, and Kathleen Collins. They were honored for their work to preserve thousands of Forest Service historical documents. Since 1991, Forest Service and NARA staff reviewed thousands of cubic feet of records that were originally scheduled for destruction. During this process, the most significant records were reappraised as permanent and accessioned by the San Bruno Regional Archives, along with detailed inventories created by project staff.

Lux led the decade-long cataloging effort, assisted by agency staffer Mario Chocooj.

Included are materials on land management planning, administrative policies and initiatives, and information about Forest Service historic structures and cultural sites throughout California. A recent official history of the Forest Service in California, *The Ever-Changing View*, by Anthony Godfrey, made use of this collection.

Highlights include documentation of the Forest Service's administration of the Civilian Conservation Corps during the Great Depression; national forests' historical overviews and reports; fire reports; attempts to eradicate white pine blister rust; and timber nurseries and experimental forests.

Additional records include manuals on appraising and quantifying the value of individual trees; surveys of flora and fauna; assessments and policies about grazing lands; standardized building plans for a variety of structures (like ranger cabins and fire lookout stations); oral histories and memoirs; staff directories (a valuable source for genealogists); early agency manuals and directives; and many other publications and documents that trace the evolving priorities and programs of the Forest Service since 1906.

This collection adds to the nearly 2,000 cubic feet of Forest Service archives, dating from 1870 to the late 1990s, already held by the San Bruno Regional Archives. These records relate to regional planning, grazing and range management, forest insect pest control, fires and floods, recreation demands, land status, and other subjects, in California and Nevada. They consist of textual records as well as extensive fire history, Federal Power Commission, and General Land Office maps.

NARA-Sacramento State Electronic Records Forum Draws Crowd

"Building the Digital Archives," a symposium on preserving electronic records, was attended by about 60 people on July 8 at Sacramento State University. Lee Simpson, Sac State Professor of History, welcomed the group with a reminder of the ubiquitous nature of electronic information, our growing reliance on it for research in all fields, and our faulty assumption that electronic information will endure on its own.

Chris Garmire, the Electronic Records Archivist at the California State Archives, spoke about their project to capture and preserve the State's geospatial records in the California Spatial Information Library (funded by the *National Historical Publications and Records Commission*, the granting arm of the National Archives).

Hao Tran, Assistant Director of the Forest Service's Pacific Southwest Research Station, talked about national efforts to preserve research and development data produced in the past by Forest Service scientists using a variety of older software formats.

NARA's Kathleen Collins, outlined the steps Forest Service has taken to locate,

New NARA Records Storage Facility Standards Bulletin Issued

NARA Bulletin 2008-06, Records Storage Facility Standards, issued last month, reminds Federal agencies of their obligations to ensure that records storage facilities used to store their agency records meet NARA's records storage facility standards outlined in 36 CFR part 1228, subpart K. It also provides guidance to assist agencies with obtaining NARA approval.

The attachment to this bulletin provides the updated checklist that NARA uses to evaluate facility compliance with the standards. The bulletin also replaces NARA Bulletin 2005-07 Records Storage Facility Standards, dated September 27, 2005, which is now canceled. The bulletin is on the NARA website at
