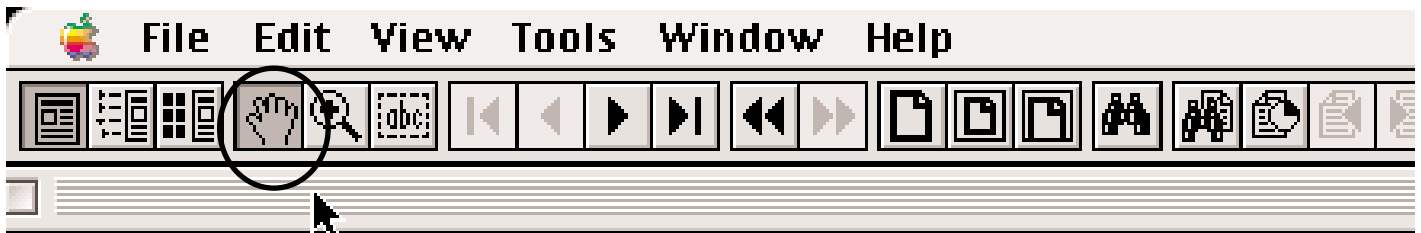

Tips on using the Acrobat Reader

1. Open the Acrobat Reader and then open the PDF file.
 - One method to open the PDF file is to Double Click on the file.
 - Another method is select File "Open" then navigate to the folder where the file is located.
2. Once the file is opened on the monitor select the Hand Tool in the **tool bar**. (see image)

4. Complete all required fields on the order form.
5. Go to File "Save a Copy" or File "Save As" to rename file.
 - Once you have renamed file Click OK
6. Open your email program/application to compose a new e-mail message.
