Summary of Terms for the Temporary Guaranty Program for Money Market Funds

Potential program participants should carefully review the Guarantee Agreement for more detailed information.

| Eligibility | The Program is open to money market funds that are registered under the Investment Company Act of 1940 ("1940 Act") and that offer securities registered under the Securities Act of 1933. In addition, the Fund must have a policy of maintaining a stable net asset value or share price of \$1.00 per share and must operate in compliance with Rule 2a-7 under the 1940 Act. Finally, the Fund's market-based net asset value ("NAV") per share on September 19, 2008 must have been at least \$0.995. |

| Shareholder Coverage | The Program covers the shares of any shareholder of record on September 19, 2008. The number of shares covered will be the lesser of: (a) the number of shares owned on September 19, 2008; or (b) the number of shares owned on the date on which a Guarantee Event (as defined below) occurs. |
| | Covered shareholders will receive \$1.00 per covered share upon liquidation of a Fund, subject to adjustment and the overall amount available to all Funds under the Program. |
| Termination Date of the Program | December 18, 2008, unless extended at sole discretion of the Treasury Department. However, in no event will the Program extend later than September 18, 2009. |
| Extension of Participation | If the Program is extended, a Fund may continue to participate if, among other things, the Fund has a Market-Based NAV per share on the extension date of at least \$0.995. |
| Program Participation Payments | In order to participate in the Program, eligible funds must make the following payment to the Treasury Department. \$1.00 multiplied by sum of all covered shares in the Fund multiplied by: |

| Trigger Event for Guarantee Payment | First date after September 19, 2008, on which the Market-Based NAV of the Fund is less than \$0.995 (the "Guarantee Event"), unless promptly cured. |
| Guarantee Payment | Conditions for payment of the Guarantee Payment, include the following: (i) The Guarantee Event must occur on or before the Termination Date; |
