The Office decision to eliminate the program was based on the fact that over time few inventors benefited from filing disclosure documents and many users erroneously thought they were filing a patent application.

TEAS CELEBRATES ONE MILLION

<u>T</u>rademark <u>E</u>lectronic <u>Application System (TEAS)</u> has reached the filing milestone of one million trademark applications filed via the USPTO website. Application one million was filed by Donald Junck of Sioux City, Iowa on November 29, 2006 for "Bait Craft" and logo. There were 354,775 TEAS applications in 2006.

Search THE ARRIVAL OF UPWS 2.8 ENHANCEMENTS

InterfacesUPWS 2.8 was released for public use in January, 2007. You may obtain a detailed guide
explaining UPWS 2.8 changes at each facility On-Line Assistance Desk. Examples of popular
enhancements that are now in use are: an improved Note Pad function; improvements to the
Text Transfer function; workstation Problem/Suggestion Report Template; and, saving of X-
Search strategies.

NEW DESIGN SEARCH CODES FOR X-SEARCH

The design search codes for X-Search were modified on January 7, 2007. More than 80 new design codes were added. Many larger existing design code sections were modified to create smaller sections. Be sure to check the X-Search "Design Code Index" under the Help tab for the up-to-date codes. An example, Smiley faces have their own section under humans: 02.11.16. Emoticons are now coded as 24.17.21 rather than in the broader section of punctuation. A reference copy of the updated Design Code Manual is available at each facility On-Line Assistance Desk.

Before beginning a new search on PubEAST, create a customized workspace of favorite settings.

Steps for Creating a "Customized" Workspace

- Access EAST
 - o From the Menu Bar, select TOOLS. From the Dropdown list select OPTIONS
 - o Select the specific TABS you may want to change: Search, Retrieval, Display, Files, etc.
 - o Once the changes have been made, select FILE
 - From the Drop down menu select: SAVE AS DEFAULT WORKSPACE LAYOUT

Steps for Selecting a Browser Display Layout

- Access EAST
- o From an open Browser window displaying a patent image, select WINDOW
- From the Dropdown list select BROWSER LAYOUT OPTIONS
- o Select one of the 7 predefined Browser layouts available
- o Click OK
- From the Menu Bar, select FILE. From the Dropdown list select: SAVE AS DEFAULT BROWSER LAYOUT

Steps for Saving Changes in Workspace

- o Access EAST
- o Activate a query
- From the Menu Bar, select SAVE WORKSPACE AS
- o From the File Name line, give this new workspace a NAME and click Enter
- Each time you exit the system you will be prompted: Save Changes in Workspace Steps for Deleting Folders
 - Highlight the L# from the Active Folder, right click and select DELETE
 - This moves the L# to the Trash Folder, right click and select EMPTY TRASH

HIGHLIGHTING TERMS IN PUBEAST

With the latest version of PubEAST, different colored arrows are used to indicate the status of the highlighting feature for key words searched. When a search is conducted in PubEAST and the results are displayed in the Active folder, an icon with a green arrow pointing to the L number indicates that the highlighting has been turned off. An icon with a blue arrow indicates the highlighting has been turned on. More details of this feature are available in a handout at each On-Line Assistance Desk.
