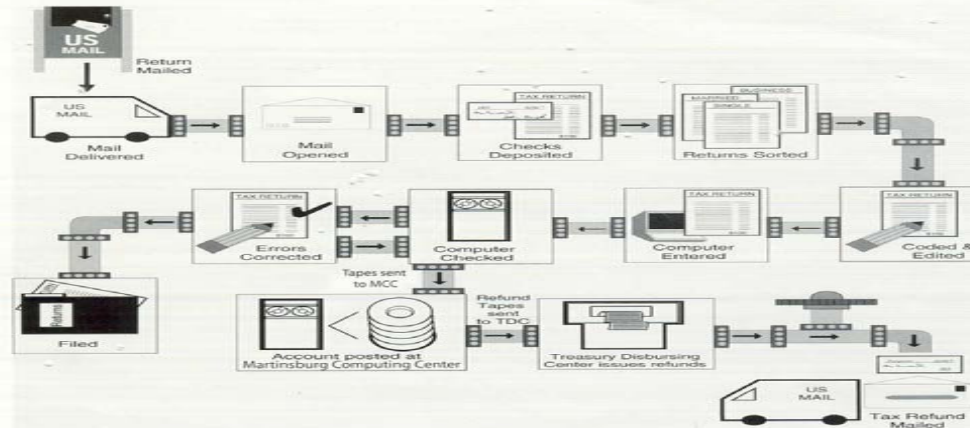

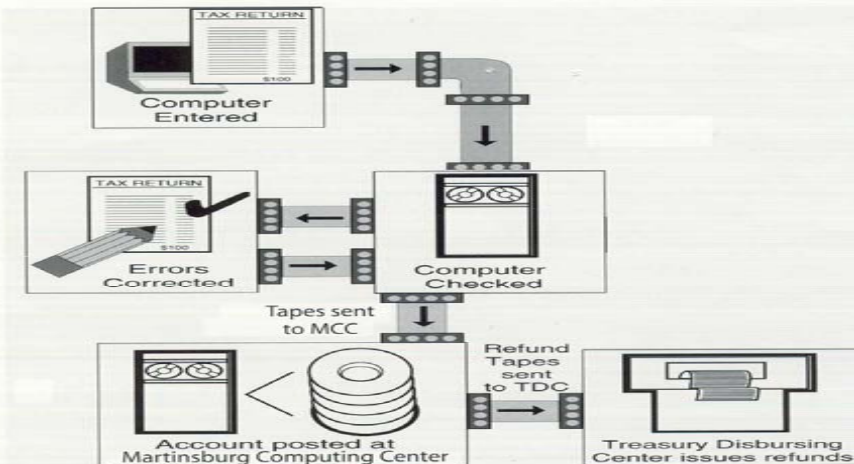


E-file vs Paper Processing

1040 PAPER Processing Pipeline

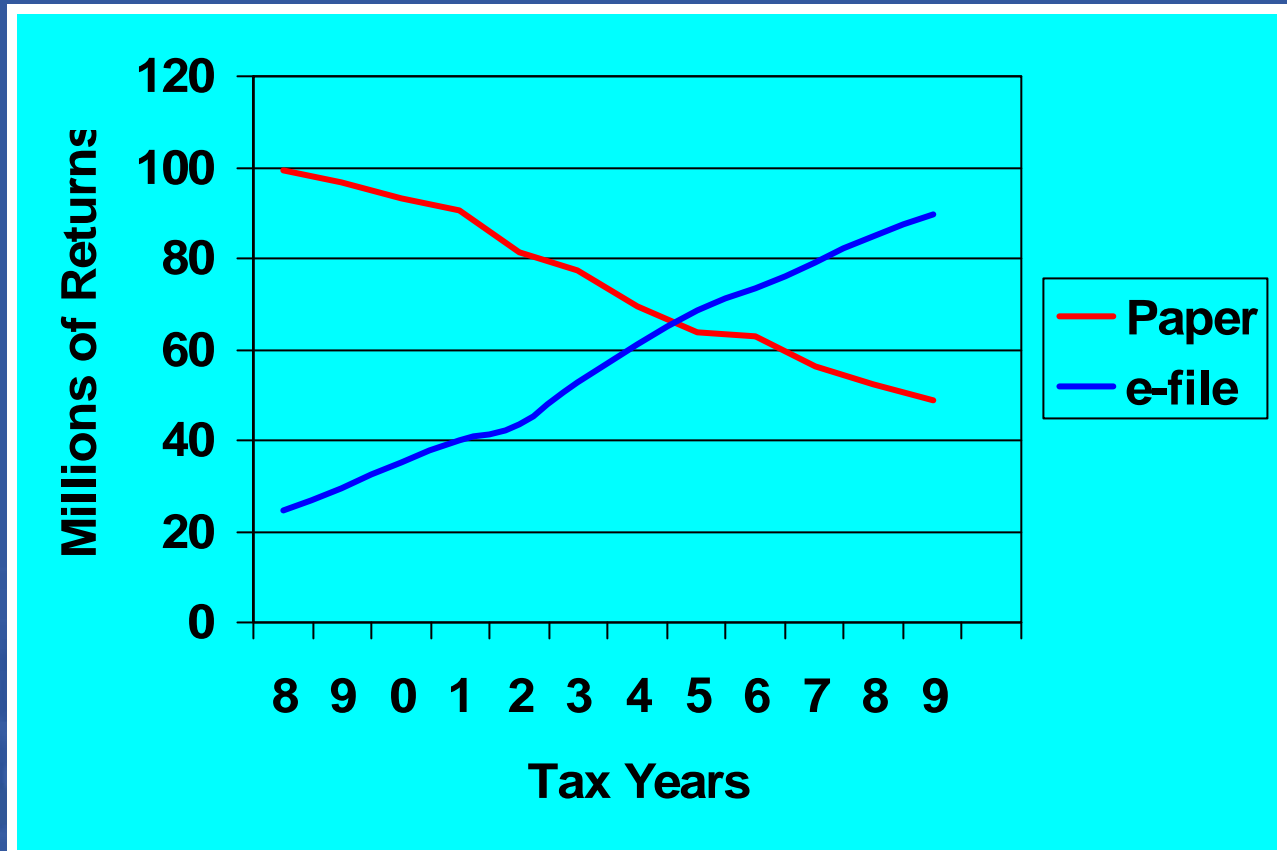


1040 e-file Processing Pipeline

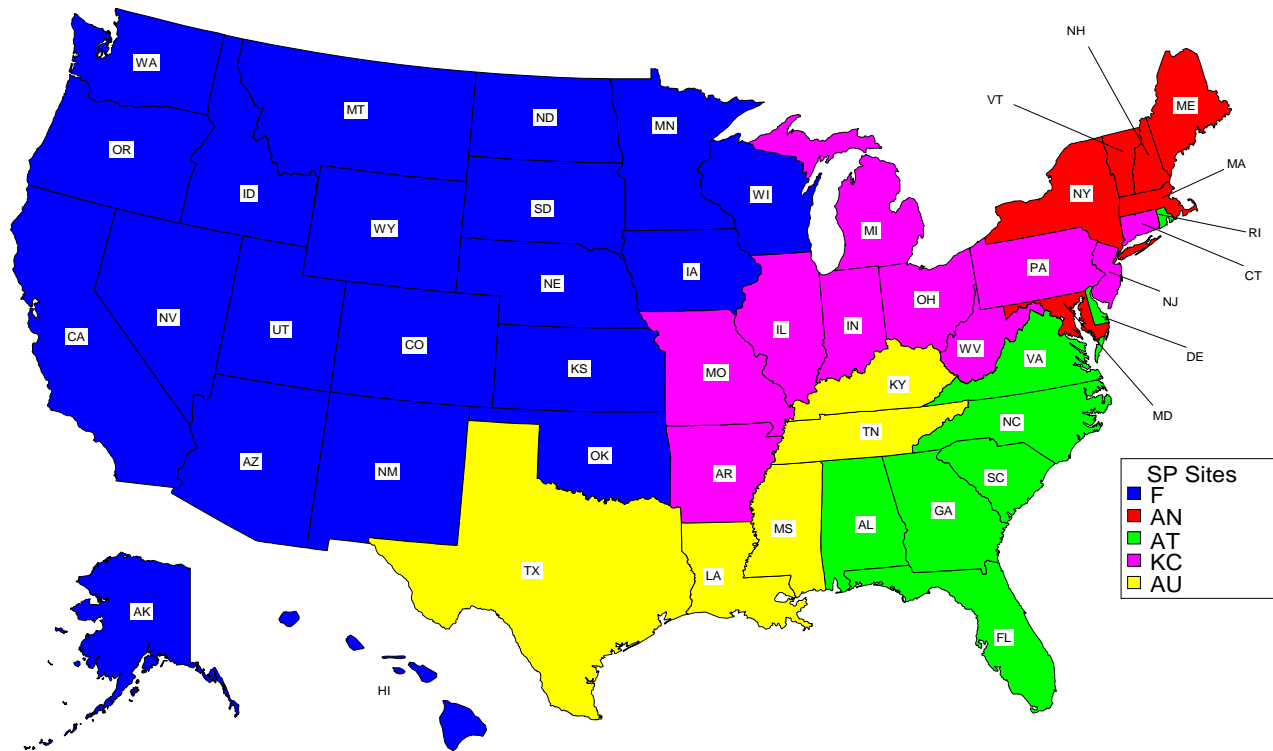

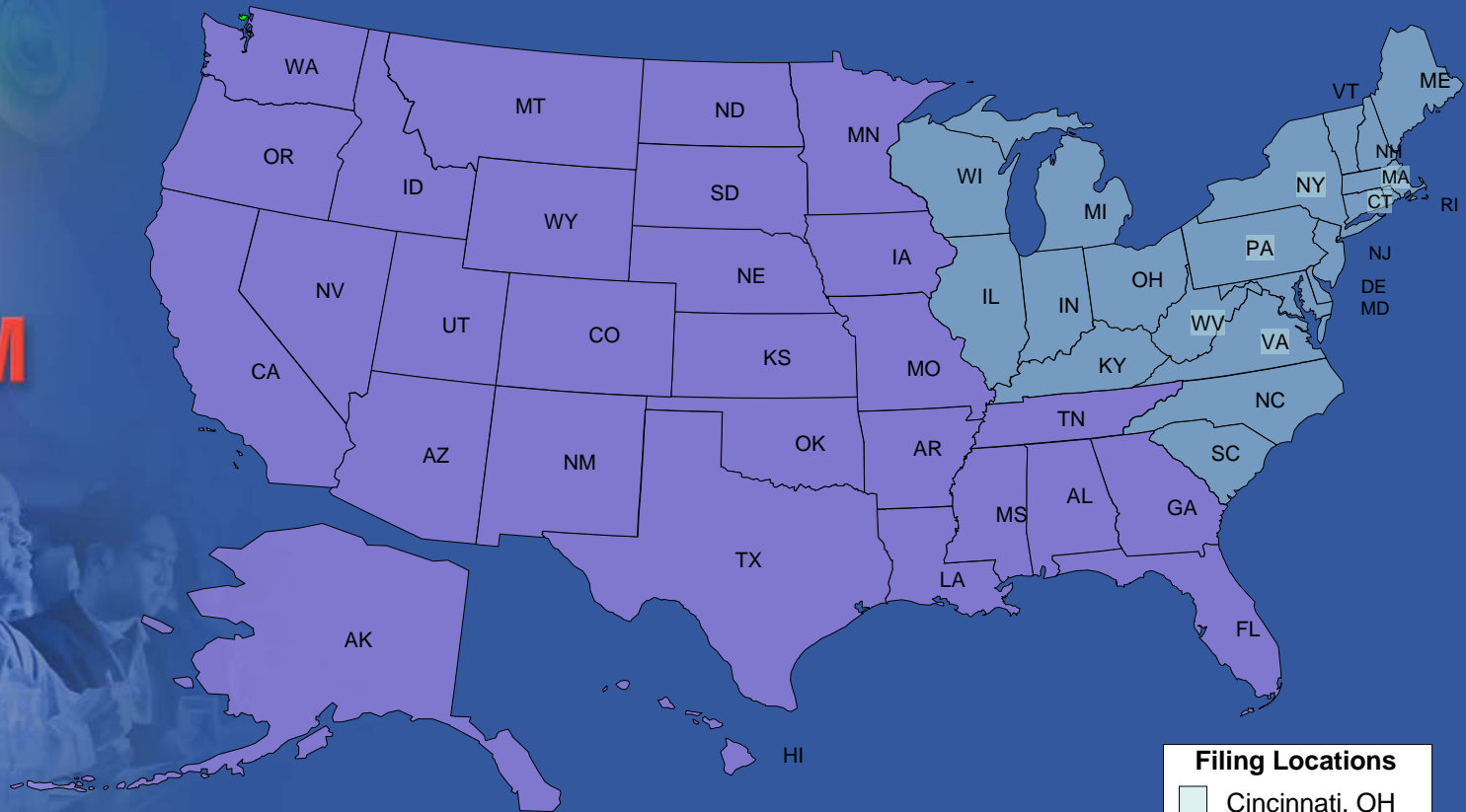

- TIN/Names do not match records
- EITC Computations Incorrect
- Missing Signature
- Missing Forms and Schedules

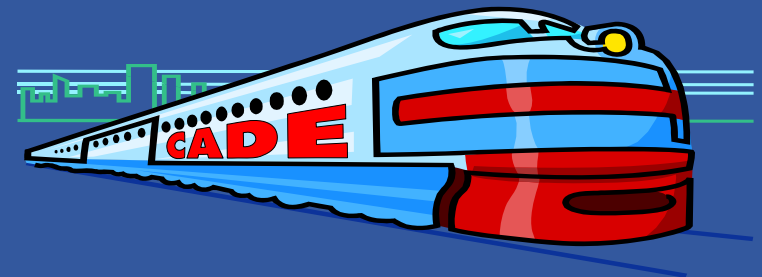
