To the President of the Senate and the Speaker of the House of Representatives

On January 9, 1991, the President submitted to the Congress his second special impoundment message for fiscal year 1991. This message reports two new deferrals and revises the amounts of four deferrals previously reported. We have reviewed these deferrals and found them to be in accordance with the Impoundment Control Act, 2 U.S.C. § 681, et. seq, as amended.

Enclosure I provides specific information on three of the deferrals which we believe will be useful to the Congress in its examination of the message. Enclosure II provides a list of the deferrals as reported by the President.

FUNDS APPROPRIATED TO THE PRESIDENT:

The latest apportionment statements for these accounts show total budgetary resources of \$3,347,966,398 and not \$3,342,779,021 as reflected in the message. According to OMB's cumulative report, submitted to the Congress on February 7, 1991, and the latest apportionment statements for these accounts the amount deferred is \$1,895,176,000 and not \$2,092,829,284 as shown in the message. This change reflects subsequent releases of funds from these accounts.

International Security Assistance Foreign Military Financing Amount Deferred: \$4,820,649,305 1111082

According to OMB's cumulative report, submitted to the Congress on February 7, 1991, as well as the most recent apportionment statement for this account, \$1,595,195,000 of the amount reported as deferred has been released. The amount currently deferred is \$3,225,454,305.

According to the most recent apportionment schedule for this account, dated January 14, 1991, total budgetary resources are \$60,537,650 not \$60,536,000 as reported in the message. The apportionment schedule reflects an additional \$1,650 in actual unobligated balance brought forward from the prior fiscal year. Furthermore, according to the latest apportionment statement for this account, \$12,100,000 of the amount reported in the message as deferred has been released. The amount currently deferred is \$46,937,650.
