**8. CHARGE**  
**VIOLATIONS:**  
 Investigation disclosed that during the taxable periods from January 1, 2004, through June 31, 2006, the proponent is alleged to have underpaid excise tax by failing to account properly for receipts of bulk alcohol in bond and by failing to account for inventory shortages of finished product as well in violation of Title 26, United States Code, Sections 5001(a)(1), 5005, 6651, 6656 and Title 27, Code of Federal Regulations, Sections 19.24 and 19.562(a).

**BUSINESS IN WHICH ENGAGED:**  
 The proponent is a duly qualified distilled spirits plant.

**DATE OR PERIOD AND LOCATION OF VIOLATIONS:**  
 January 2004 through June 2006 at the proponents premises at 58 Vale Road, Brookfield, CT 06804.

**AMOUNT AND TERMS OF OFFER:**  
 The proponent has submitted an offer of \$475,000.00 in compromise of the above violations incurred under the Internal Revenue Code.

**RECOMMENDATION:**  
 The Director, National Revenue Center recommends acceptance of the offer. In view of doubt as to liability and potential litigation hazards, acceptance of this Offer in Compromise, as submitted, is warranted.
