

SANTA ROSA WILDERNESS ADDITIONS
50,445 Acres
Designated October 31, 1994 by the California Desert Protection Act,
Public Law 103-433

This is the final legal description as required in Section 103(b) of the above mentioned Act. It describes the boundary for the Santa Rosa Wilderness Area located in Riverside County, California and managed by the Bureau of Land Management. The boundary is more particularly described as follows:

From the closing township corner, common to sections 1 and 6, of Ts. 6 and 7 S., Rs. 5 and 6 E., SBM. said point being the point of beginning:

thence westerly along the township line to point 1, the 1/4 corner of section 36 only, T. 6 S., R. 5 E.;

thence northerly on the north/south centerline of section 36 to point 2, the center 1/4 corner of section 36;

thence easterly on the east/west centerline of section 36 to point 3, the center east 1/16 corner of section 36;

thence northerly on the north/south centerline of the NE 1/4 of section 36 to point 4, the north east 1/16 corner of section 36;

thence westerly along the east/west centerline of the NE 1/4 of section 36 to point 5, the intersection with a line parallel with and 300 feet easterly of the centerline of Highway 74;

thence northerly, parallel with and 300 feet easterly of said centerline to point 6, the intersection with the line between sections 25 and 36;

thence easterly on the east/west section line between sections 25 and 36 to point 7, the east boundary of T. 6 S., R. 5 E.,

thence northerly on the range line between sections 25 and 30 to point 8, the intersection with a line parallel with and 300 feet southerly of the centerline of Highway 74;

thence northeasterly, parallel with and 300 feet southerly of the centerline of Highway 74, to point 9, the intersection with the section line between sections 19 and 30, T. 6 S., R. 6 E.;

thence easterly on the section line between sections 19 and 30, 20 and 29, 21 and 28, 22 and 27, 23 and 26 to point 10, the corner of sections 23, 24, 25 and 26, T. 6 S., R. 6 E.;

thence southerly on the section line between sections 25 and 26 to point 11, the corner of sections 25, 26, 35 and 36;

thence easterly on the section line between sections 25 and 36 to point 12, the east boundary of T. 6 S., R. 6 E.;

thence northerly on the range line between sections 25 and 30, 24 and 30 to point 13, the section corner common to sections 19 and 30, T. 6 S., R. 7 E.;

thence easterly on the section line between sections 19 and 30, 20 and 29 to point 14, the west 1/16 corner of sections 20 and 29, T. 6 S., R. 7 E.;

thence southerly on the north/south centerline of the NW 1/4 of section 29 to point 15, the northwest 1/16 corner of section 29;

thence westerly on the east/west centerline of the NW 1/4 of section 29 to point 16, the north 1/16 corner of sections 29 and 30;

thence southerly on the line between sections 29 and 30 to point 17, the corner of sections 29, 30, 31 and 32;

thence easterly on the line between sections 29 and 32 to point 18, the intersection with a line parallel with and 30 feet westerly of the centerline of a jeep trail, said intersection located in the east 1/2 of section 29;

thence southwesterly, parallel with and 30 feet westerly of said centerline to point 19, the intersection with the line between section 32 and 5, on the township line between Ts. 6 and 7 S., R. 7 E.;

thence westerly on said township line to point 20, the corner of sections 5 and 6 only, T. 7 S., R. 7 E.;

thence southerly on the line between sections 5 and 6 to point 21, the 1/4 corner of sections 5 and 6;

thence southeasterly to point 22, the 1/4 corner of sections 5 and 8;

thence easterly on the line between sections 5 and 8 to point 23, the corner of sections 4, 5, 8 and 9;

thence southeasterly to point 24, a saddle located in the northeast 1/4 of section 9, having NAD 1927 coordinates of 33°34'38" N. latitude, 116°15'13" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "MARTINEZ MTN., CALIF.", 1981;

thence southeasterly to point 25, the 1/4 corner between sections 9 and 10;

thence easterly to point 26, the easterly toe of spur, having NAD 1927 coordinates of 33°34'35" N. latitude, 116°14'48" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "VALERIE, CALIF.", 1956;

thence southeasterly to point 27, the westerly toe of a spur, at the intersection of a wash with a drainage, located in the southwest 1/4 of section 10, having NAD 1927 coordinates of 33°34'26" N. latitude, 116°14'43" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "VALERIE, CALIF.", 1956;

thence southeasterly along said drainage to point 28, a bench on a ridge;

thence southeasterly to point 29, the intersection of the line between sections 10 and 15 with a ridge, said intersection located in the southeast 1/4 of section 10;

thence southeasterly to point 30, the intersection of the line between sections 14 and 15 with the thread of a wash, said intersection located in the northeast 1/4 of section 15;

thence northeasterly to point 31, a knob located in the southeast 1/4 of section 11, having NAD 1927 coordinates of 33°34'20" N. latitude, 116°13'24" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "VALERIE, CALIF.", 1956;

thence southerly to point 32, the 1/4 corner of sections 11 and 14;

thence southeasterly to point 33, the southerly edge of plateau, at the head of a drainage, having NAD 1927 coordinates of 33°34'05" N. latitude, 116°13'22" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "VALERIE, CALIF.", 1956;

thence southeasterly to point 34, a saddle located in the southeast 1/4 of section 14, having NAD 1927 coordinates of 33°33'33" N. latitude, 116°13'08" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "VALERIE, CALIF.", 1956;

thence southeasterly to point 35, the corner of sections 13, 14, 23 and 24;

thence southerly on the line between sections 23 and 24 to point 36, the intersection with the thread of a drainage located in the northwest 1/4 of section 24;

thence southeasterly to point 37, a saddle located near the east/west centerline of section 24, having NAD 1927 coordinates of 33°32'51" N. latitude, 116°12'40" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "VALERIE, CALIF.", 1956;

thence southeasterly to point 38, the easterly edge of a bench on ridge located near the line between sections 24 and 25, having NAD 1927 coordinates of 33°32'25" N. latitude, 116°12'30" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "VALERIE, CALIF.", 1956;

thence southerly to point 39, the easterly edge of a bench on ridge located in the northwest 1/4 of section 25, having NAD 1927 coordinates of 33°32'04" N. latitude, 116°12'33" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "VALERIE, CALIF.", 1956;

thence easterly to point 40, a point 60 feet West of the westerly toe of spur of a knoll, said toe having NAD 1927 coordinates of 33°32'02" N. latitude, 116°12'12" W. longitude, as determined by GPS observations, +- 2-5 meters accuracy, said point being also 30 feet westerly of the centerline of the Martinez Canyon jeep trail;

thence southwesterly, parallel with and 30 feet northwesterly of said centerline to point 41, a point South of a knoll located in the southeast 1/4 of section 35, said knoll having NAD 1927 coordinates of 33°30'48" N. latitude, 116°13'20" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "VALERIE, CALIF.", 1956;

thence South to point 42, the intersection with a line parallel with and 30 feet southerly of said centerline;

thence northeasterly, parallel with and 30 feet southeasterly of said centerline to point 43, the aforesaid westerly toe of spur of a knoll;

thence southeasterly to point 44, a knob located in the northwest 1/4 of section 31, T. 7 S., R. 8 E., having NAD 1927 coordinates of 33°31'30" N. latitude, 116°11'34" W. longitude, as scaled from the 7.5 minute quadrangle "VALERIE, CALIF.", 1956;

thence southeasterly to point 45, the center 1/4 corner of section 31;

thence southwesterly to point 46, the township corner of Ts. 7 and 8 S., Rs. 7 and 8 E.;

thence southerly on the range line between sections 1 and 6, sections 7 and 12 to point 47, the 1/4 corner of section 7 only, T. 8 S., R. 8 E.;

thence easterly on the east/west centerline of section 7 to point 48, the 1/4 corner of sections 7 and 8;

thence southerly on the line between sections 7 and 8 to point 49, the corner of sections 7 and 8 only;

thence easterly on the line between sections 8 and 18 to point 50, the corner of sections 17 and 18 only;

thence southerly on the line between sections 17 and 18 to point 51, the 1/4 corner of sections 17 and 18;

thence southeasterly to point 52, the 1/4 corner of sections 17 and 20;

thence easterly on the line between sections 17 and 20, sections 16 and 20 to point 53, the corner of sections 20 and 21 only;

thence southerly on the line between sections 20 and 21 to point 54, the 1/4 corner of sections 20 and 21;

thence southeasterly to point 55, the 1/4 corner of sections 21 and 28;

thence southerly on the north/south centerline of section 28 to point 56, the 1/4 corner of sections 28 and 33;

thence southeasterly to point 57, the 1/4 corner of sections 33 and 34;

thence easterly on the east/west centerline of section 34 to point 58, the 1/4 corner of sections 34 and 35;

thence southeasterly to point 59, the 1/4 corner of section 35 only, on the township line between T. 8 and 9 S., R. 8 E., SBM;

thence westerly, on the township line, Ts. 8 & 9 S., Rs. 6, 7 & 8 E. to point 60, the corner common to sections 31 and 32, T. 8 S., R. 6 E.;

thence northerly on the line between sections 31 and 32 to point 61, the corner of sections 29, 30, 31 and 32, T. 8 S., R. 6 E.;

thence westerly on the line between sections 30 and 31 to point 62, the section corner of sections 30 and 31 only, T. 8 S., R. 6 E.;

thence northerly on the range line between sections 25 and 30, sections 19 and 24, T. 8 S., Rs. 5 & 6 E., to point 63, the corner common to sections 13 and 24, T. 8 S., R. 5 E.;

thence westerly on the line between sections 13 and 24 to point 64, the corner of sections 13, 14, 23, and 24;

thence southerly on the line between sections 23 and 24 to point 65, the corner of sections 23, 24, 25, and 26;

thence westerly on the line between sections 23 and 26 to point 66, the corner of sections 22, 23, 26, and 27;

thence northerly on the line between sections 22 and 23 to point 67, the corner of sections 14, 15, 22, and 23;

thence westerly on the line between sections 15 and 22 to point 68, the corner of sections 15, 16, 21, and 22;

thence northerly on the line between sections 15 and 16, sections 9 and 10, sections 3 and 4, to point 69, the section corner of sections 3, 4, 33, and 34, on the township line, Ts. 7 & 8 S., R. 5 E.;

thence easterly between Ts. 7 & 8 S., R. 5 E. to point 70, the southeast corner of T. 7 S., R. 5 E. only;

thence southerly between of T. 8 S., Rs. 5 & 6 E. to point 71, the corner of sections 6 and 7, T. 8 S., Rs. 5 and 6 E.;

thence easterly on the line between sections 6 and 7 to point 72, the corner of sections 5, 6, 7, and 8, T. 8 S., R. 6 E.;

thence northerly on the line between sections 5 and 6 to point 73, the section corner of sections 5, 6, 31, and 32, on the township line, Ts. 7 & 8 S., R. 6 E.;

thence easterly between Ts. 7 & 8 S., R. 6 E. to point 74, the corner common to sections 34 and 35, T. 7 S., R. 6 E.;

thence northerly on the line between sections 34 and 35 to point 75, the corner of sections 26, 27, 34, and 35;

thence easterly on the line between section 26 and 35 to point 76, the corner of sections 25, 26, 35, and 36;

thence northerly on the line between sections 25 and 26 to point 77, the corner of sections 23, 24, 25, and 26;

thence westerly on the line between sections 23 and 26 to point 78, the corner of sections 22, 23, 26, and 27;

thence northerly on the line between sections 22 and 23, sections 14 and 15, sections 10 and 11 to point 79, the corner of sections 2, 3, 10 and 11;

thence westerly on the line between sections 3 and 10, sections 4 and 9, sections 5 and 8, sections 6 and 7 to point 80, the section corner of sections 6 and 7, on the range line, T. 7 S., Rs. 5 & 6 E.;

thence northerly on the range line between sections 1 and 6, to the closing township corner common to sections 1 and 6, Tps. 6 and 7 S., Rs. 5 and 6 E., said closing corner being the point of beginning.

End of Description

The above description containing approximately 50,445 acres utilizes Clark Lake Northeast, Collins Valley, La Quinta, Martinez Mountain, Oasis, Rabbit Peak, Rancho Mirage, Toro Peak, and Valerie 7.5 minute quadrangle maps prepared by the USGS. The boundary calls listed herein are a result in part of scaling distances from said quad maps and are not a result of survey. All courses have been depicted upon the above mentioned quad maps and are made part of this official record. Acreage is calculated from the CASO ArcInfo wilderness coverage.
