

**OLD WOMAN MOUNTAINS WILDERNESS**  
**161,317 Acres**  
**Designated October 31, 1994 by the California Desert Protection Act,**  
**Public Law 103-433**

This is the final legal description as required in Section 103(b) of the above mentioned Act. It describes the boundary for the Old Woman Mountains Wilderness Area located in San Bernardino County, California and managed by the Bureau of Land Management. The boundary is more particularly described as follows:

From the intersection of the northeasterly boundary of the Metropolitan Water District power transmission line right-of-way boundary, LA 052055, and a line parallel with and 300 feet northeasterly of the centerline of the Atchison, Topeka, and Santa Fe Railroad, said intersection located in the southwest 1/4 of section 16, T. 2 N., R. 18 E., SBM, and being the point of beginning.

thence northwesterly, parallel with and 300 feet northeasterly of centerline of said railroad, to point 1, the intersection of a line parallel with and 100 feet northeasterly of the toe of a diversion dike, said intersection located in the northeast 1/4 of section 7;

thence northwesterly, parallel with and 100 feet northeasterly of the toe of said diversion dike, to point 2, the intersection of the north/south centerline of the northeast 1/4 of the northwest 1/4 of section 7;

thence northwesterly, to point 3, the north-north 1/64 section corner of section 12 only, on the range line between T. 2 N., Rs. 17 and 18 E.;

thence westerly, on the east/west centerline of the northeast 1/4 of the northeast 1/4, the northwest 1/4 of the northeast 1/4, the northeast 1/4 of the northwest 1/4 and the northwest 1/4 of the northwest 1/4 of section 11, and the east/west centerline of the northeast 1/4 of the northeast 1/4, the northwest 1/4 of the northeast 1/4, the northeast 1/4 of the northwest 1/4, and the northwest 1/4 of the northwest 1/4 of section 12, T. 2 N., R. 17 E., to point 4, the north-north 1/64 section corner of section 11 only, on the section line between sections 10 and 11;

thence southerly, between sections 10 and 11, to point 5, the intersection of a line parallel with and 1200 feet northeasterly of centerline of said railroad;

thence northwesterly, parallel with and 1200 feet northeasterly of centerline of said railroad, to point 6, the intersection of the north/south centerline of the southeast 1/4 of the southwest 1/4 of section 11, T. 3 N., R. 16 E.;

thence northerly, on the north/south centerline of the southeast 1/4 of the southwest 1/4 and the northeast 1/4 of the southwest 1/4 of section 11, to point 7, the southeast-northwest 1/64 section corner of section 11;

thence northwesterly, to point 8, the north-north 1/64 section corner of sections 10 and 11;

thence northwesterly, on the prolongation of a line determined by the bearing between the southeast-northwest 1/64 and the north-north 1/64 section corners of section 11, to point 9, the intersection of a line parallel with and 30 feet

southeasterly of centerline of a jeep trail, said intersection located in the northeast 1/4 of the northeast 1/4 of the northeast 1/4 of section 10;

thence northeasterly, parallel with and 30 feet southeasterly of centerline of said jeep trail, to point 10, a point West of a peak on a ridge line, said peak having NAD 1927 coordinates 34°25'14" N. latitude, 115°13'59" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "Sheep Camp Spring, Calif.," 1985 (provisional), and having an elevation of 651 meters as shown on said quadrangle;

thence East, to point 11, said peak;

thence northeasterly, along said ridge line, to point 12, a peak, said peak having NAD 1927 coordinates 34°25'27" N. latitude, 115°12'41" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "Sheep Camp Spring, Calif.," 1985 (provisional), and having an elevation of 913 meters as shown on said quadrangle;

thence East, to point 13, the intersection of the section line between sections 20 and 21;

thence northeasterly, to point 14, a peak having NAD 1927 coordinates 34°25'33" N. latitude, 115°12'22" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "Sheep Camp Spring, Calif.," 1985 (provisional), and having an elevation of 832 meters as shown on said quadrangle;

thence northwesterly, to point 15, the west-west-west 1/256 corner of sections 16 and 21;

thence westerly, between sections 16 and 21, 17 and 20, to point 16, the intersection of a line parallel with and 30 feet easterly of centerline of a jeep trail;

thence northwesterly, parallel with and 30 feet northeasterly of centerline of said jeep trail, to point 17, the intersection of a line parallel with and 30 feet northeasterly of the prolongation of a jeep trail centerline, said intersection having NAD 1927 coordinates 34°25'52" N. latitude, 115°12'39" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "Sheep Camp Spring, Calif.," 1985 (provisional);

thence northwesterly, parallel with and 30 feet northeasterly of centerline of said jeep trail, to point 18, the intersection of a line parallel with and 30 feet southeasterly of centerline of a jeep trail located in Browns Wash, said intersection having NAD 1927 coordinates 34°25'57" N. latitude, 115°12'53" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "Sheep Camp Spring, Calif.," 1985 (provisional);

thence northeasterly, parallel with and 30 feet southeasterly of centerline of said jeep trail, to point 19, the intersection of the section line between sections 15 and 16;

thence northerly, between sections 15 and 16, to point 20, the intersection of a line parallel with and 30 feet northwesterly of centerline of said jeep trail;

thence southwesterly, parallel with and 30 feet northwesterly of centerline of said jeep trail, to point 21, the intersection of a line parallel with and 30 feet northeasterly of centerline of a jeep trail, said intersection located in the northwest 1/4 of the southeast 1/4 of section 17;

thence southwesterly, parallel with and 30 feet northwesterly of centerline of said jeep trail, to point 22, the intersection of the section line between sections 17 and 18;

thence northwesterly, to point 23, the intersection of a line parallel with and 30 feet northwesterly of centerline of a

jeep trail, perpendicular to the jeep trail centerline at its terminus, said terminus having NAD 1927 coordinates 34°26'03" N. latitude, 115°13'51" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "Sheep Camp Spring, Calif.," 1985 (provisional);

thence southwesterly, parallel with and 30 feet northwesterly of centerline of said jeep trail, to point 24, the intersection of a line parallel with and 30 feet northerly of centerline of a jeep trail, said intersection located near the 1/4 section corner of sections 18 and 19;

thence westerly, parallel with and 30 feet northerly of centerline of said jeep trail, to point 25, the intersection of a line parallel with and 30 feet northwesterly of the projected centerline of a jeep trail prolongation, said intersection located near the 1/4 section corner of sections 18 and 19;

thence southwesterly, parallel with and 30 feet northwesterly of centerline of said jeep trail, to point 26, the intersection of the east/west centerline of section 2, T. 3 N., R. 16 E.;

thence westerly, on the east/west centerline of section 2, to point 27, the intersection of a line parallel with and 30 feet easterly of centerline of a jeep trail;

thence northwesterly, parallel with and 30 feet northeasterly of centerline of said jeep trail, to point 28, the intersection of a line parallel with and 30 feet southerly of centerline of a jeep trail, said intersection located in the southwest 1/4 of section 20, T. 5 N., R. 16 E.;

thence southeasterly changing to northeasterly, parallel with and 30 feet southwesterly changing to southeasterly of centerline of said jeep trail, to point 29, the intersection with a line parallel with and 30 feet southerly of centerline of a jeep trail, said intersection located near the east-east 1/64 section corner of sections 18 and 19, T. 5 N., R. 17 E.;

thence northeasterly, parallel with and 30 feet southeasterly of centerline of said jeep trail near southerly edge of wash, to point 30, the intersection of a line parallel with and 30 feet southeasterly of centerline of a jeep trail, said intersection located near the north-south 1/64 section corner of sections 16 and 17;

thence northeasterly, parallel with and 30 feet southeasterly of centerline of said jeep trail, to point 31, a point perpendicular to the jeep trail centerline at its terminus, said terminus having NAD 1927 coordinates 34°32'43" N. latitude, 115°11'02" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "Old Woman Statue, Calif.," 1985 (provisional);

thence southerly perpendicular to the jeep trail centerline through its terminus point, to point 32, the intersection of a line parallel with and 30 feet southerly of centerline of said jeep trail terminus;

thence southwesterly, parallel with and 30 feet northwesterly of centerline of said jeep trail, to point 33, the intersection of a line parallel with and 30 feet northeasterly of centerline of a jeep trail, said intersection located in the southwest 1/4 of section 20, T. 5 N., R. 16 E.;

thence northwesterly, parallel with and 30 feet northeasterly of centerline of said jeep trail, to point 34, the intersection of a line parallel with and 30 feet southerly of centerline of a jeep trail, said intersection located near the center 1/4 section corner of section 7;

thence easterly, changing to northeasterly, changing to northwesterly, parallel with and 30 feet southerly, changing to southeasterly, changing to northeasterly of centerline of said jeep trail, to point 35, the intersection of the east/west centerline of the southwest 1/4 of the northwest 1/4 of the southwest 1/4 of section 33, T. 6 N., R. 17 E.;

thence westerly, on said east/west centerline, to point 36, the intersection of a line parallel with and 30 feet westerly of centerline of said jeep trail,

thence southeasterly, turning southwesterly, parallel with and 30 feet southwesterly, turning northwesterly of centerline of said jeep trail, to point 37, the intersection of a line parallel with and 30 feet northeasterly of centerline of a jeep trail, said intersection located near the center 1/4 section corner of section 7, T. 5 N., R. 16 E.;

thence northerly, parallel with and 30 feet easterly of centerline of said jeep trail, to point 38, the intersection of a line parallel with and 50 feet southeasterly of the southeasterly boundary of the Four Corners Pipeline right-of-way, LA0152777, said intersection located near the west 1/16 section corner of section 6 only, on the township line, Ts. 5 and 6 N., R. 16 E.;

thence northeasterly, parallel with and 50 feet southeasterly of said southeasterly right-of-way boundary, to point 39, the intersection of a line parallel with and 30 feet southwesterly of centerline of Sunflower Springs Road, said intersection located in the southwest 1/4 of section 26, T. 7 N., R. 17 E.;

thence southeasterly, parallel with and 30 feet southwesterly of centerline of said jeep trail, to point 40, the intersection of a line parallel with and 30 feet northeasterly of centerline of a jeep trail, said intersection located in the southeast 1/4 of section 2, T. 6 N., R. 17 E.;

thence northwesterly, parallel with and 30 feet northeasterly of centerline of said jeep trail, to point 41, the intersection of the section line between sections 2 and 3;

thence southwesterly, to point 42, the center-south 1/16 section corner of section 3;

thence southerly, on the north/south centerline of section 3, to point 43, the 1/4 section corner of sections 3 and 10;

thence easterly, between sections 3 and 10, to point 44, the east 1/16 section corner of sections 3 and 10;

thence southerly, on the north/south centerline of the east 1/2 of section 10, to point 45, the intersection of the crest of a ridge, said intersection having NAD 1927 coordinates 34°37'20" N. latitude, 115°11'04" W. longitude, as scaled from the 7.5 minute U.S.G.S. quadrangle "Old Woman Statue, Calif.," 1985 (provisional);

thence westerly, turning southerly, on said crest of ridge, to point 46, the intersection of the section line between sections 10 and 15, said intersection located near the west-east 1/64 section corner of sections 10 and 15;

thence easterly, between sections 10 and 15, to point 47, the intersection of a line parallel with and 30 feet southeasterly of centerline of a jeep trail;

thence northeasterly, parallel with and 30 feet southeasterly of centerline of said jeep trail, to point 48, the intersection of a line parallel with and 30 feet southwesterly of centerline of a jeep trail, said intersection located in the northeast 1/4 of section 11;

thence southeasterly, turning northeasterly, parallel with and 30 feet southwesterly, turning southeasterly of centerline of said jeep trail, to point 49, the intersection of a line parallel with and 30 feet southeasterly of centerline of a jeep trail, said intersection located in the southwest 1/4 of the northwest 1/4 of section 12;

thence northeasterly, turning southeasterly, turning southerly, parallel with and 30 feet southeasterly, turning southwesterly, turning westerly of centerline of said jeep trail, to point 50, the intersection of a line parallel with and

30 feet northeasterly of centerline of a westerly bearing jeep trail, said intersection located in the southwest 1/4 of section 17, T. 5 N., R. 18 E.;

thence westerly, parallel with and 30 feet northerly of centerline of said jeep trail, to point 51, a point perpendicular to the centerline of said jeep trail at its terminus, said terminus located in the southwest 1/4 of section 18;

thence South, to point 52, the intersection of a line parallel with and 30 feet southerly of centerline of said jeep trail terminus;

thence easterly, parallel with and 30 feet southerly of centerline of said jeep trail, to point 53, the intersection of a line parallel with and 30 feet southeasterly of centerline of a jeep trail, said intersection located in the southwest 1/4 of section 17;

thence northeasterly, crossing the Painted Rock Wash jeep trail, parallel with and 30 feet southeasterly of centerline of said northeasterly bearing jeep trail, to point 54, the intersection of a line parallel with and 30 feet southwesterly of centerline of a jeep trail, said intersection located in the northeast 1/4 of section 8;

thence southeasterly, parallel with and 30 feet southwesterly of centerline of said jeep trail, to point 55, the intersection of a line parallel with and 30 feet southeasterly of centerline of a jeep trail, said intersection located in the northwest 1/4 of section 25;

thence northeasterly, parallel with and 30 feet southeasterly of centerline of said jeep trail, to point 56, the intersection of the northwesterly boundary of the Metropolitan Water District power transmission line right-of-way, LA 052054, said intersection located in the northwest 1/4 of section 25;

thence southwesterly, on said right-of-way boundary LA052054, changing to LA052055, to point 57, the intersection of a line parallel with and 30 feet northeasterly of centerline of a jeep trail, said intersection located in the northwest 1/4 of section 22, T. 3 N., R. 18 E.;

thence northwesterly, parallel with and 30 feet northeasterly of centerline of said jeep trail, to point 58, a point perpendicular to centerline of said jeep trail at its terminus, said terminus located in the southeast 1/4 of the northeast 1/4 of section 11, T. 3 N., R. 17 E.;

thence southerly, perpendicular to the jeep trail centerline through its terminus point, to point 59, the intersection of a line parallel with and 30 feet southerly of centerline of said jeep trail terminus;

thence southeasterly, parallel with and 30 feet southwesterly of centerline of said jeep trail, to point 60, the intersection of the northwesterly boundary of power transmission line right-of-way LA052055, said intersection located in the northwest 1/4 of section 22, T. 3 N., R. 18 E.;

thence southwesterly, on said right-of-way boundary, to the point of beginning.

**END OF DESCRIPTION.**

The above description containing approximately 161,317 acres utilizes the Cadiz Lake Northeast, Chubbuck, East of Milligan, Essex, Milligan, Old Woman Statue, Painted Rock Wash, Sheep Camp

Spring, Skeleton Pass, and Wilhelm Spring 7.5 minute quadrangle maps prepared by the USGS. The boundary calls listed herein are in part a result of scaling distances from said quad maps and are not a result of survey. All courses have been depicted upon the above mentioned quad maps and are made a part of this official record. Acreages are calculated from the California State Office Arc/Info wilderness coverage.

I hereby certify the legal description and map herewith represent the location of the boundary of the Old Woman Mountains Wilderness designated by the California Desert Protection Act, Public Law 103-433, dated October 31, 1994.
