CLIPPER MOUNTAIN WILDERNESS 34,009 Acres Designated October 31, 1994 by the California Desert Protection Act, Public Law 103-433

This is the final legal description as required in Section 103(b) of the above mentioned Act. It describes the boundary for the Clipper Mountain Wilderness Area located in San Bernardino County, California and managed by the Bureau of Land Management. The boundary is more particularly described as follows:

From the 1/4 section corner of sections 7 and 8, T. 8 N., R. 16 E., SBM, said point being the point of beginning,

thence easterly, on the east-west centerline of section 8, to point 1, the intersection of the southwesterly edge of Clipper Valley Wash, said intersection having NAD 1927 coordinates 34°47' 48" N. latitude, 115°19' 37" W. longitude as scaled from the U.S.G.S. quadrangle "Blind Hills, Calif.," 1984 (provisional);

thence southeasterly, on the southwesterly edge of said wash, to point 2, the intersection of the section line between sections 21 and 28, said intersection having NAD 1927 coordinates 34°45′ 37″ N. latitude, 115°18′ 19 ½ ″ W. longitude as scaled from the U.S.G.S. quadrangle "Blind Hills, Calif.," 1984 (provisional);

thence westerly, between sections 21 and 28, 20 and 29, 29 and 30, to point 3, the northwest section corner of section 29 only;

thence southerly, between sections 29 and 30 and sections 31 and 32, to point 4, the section corner of sections 31 and 32, and sections 5 and 6, on the township line of T.7 and 8 N., R. 16 E.;

thence southerly between sections 5 and 6, T. 7 N., R. 16 E., to point 5, the section corner of sections 5, 6, 7 and 8;

thence easterly, between sections 5 and 8, 4 and 9, to point 6, the section corner of sections 3, 4, 9, and 10;

thence southerly, between sections 9 and 10, to point 7, the intersection of a line parallel with and 30 feet northwesterly of centerline of a jeep trail, said intersection located near the south-north 1/64 section corner of sections 9 and 10:

thence southwesterly, parallel with and 30 feet northwesterly of centerline of said jeep trail, to point 8, the intersection of a line parallel with and 100 feet northerly of centerline of a pipeline maintenance road, said intersection located in the southeast 1/4 of section 19;

thence westerly, parallel with and 100 feet northerly of centerline of said road, to point 9, the intersection of the easterly edge of a wash, said intersection having NAD 1927 coordinates 34°40′ 36" N. latitude, 115°22′ 42" W. longitude as scaled from the U.S.G.S. quadrangle "Castle Dome, Calif.," 1985 (provisional);

thence northerly, on the easterly edge of said wash, to point 10, the intersection of the north-south centerline of section 23, T. 7 N., R. 15 E.;

thence northerly, on the north-south centerline of section 23 and the north-south centerline of section 14, to point 11, the 1/4 section corner of sections 11 and 14;

thence westerly, between sections 11 and 14, to point 12, the section corner of sections 10, 11, 14, and 15;

thence northerly, between sections 10 and 11, to point 13, the 1/4 section corner of sections 10 and 11;

thence westerly, on the east-west centerline of section 10, to point 14, the center 1/4 section corner of section 10;

thence northerly, on the north-south centerline of section 10, to point 15, the center-north 1/16 section corner of section 10;

thence westerly, on the east-west centerline of the northwest 1/4 of section 10, to point 16, the north 1/16 section corner of sections 9 and 10;

thence northerly, between sections 9 and 10, to point 17, the section corner of sections 3, 4, 9, and 10;

thence westerly, between sections 4 and 9, to point 18, the section corner of sections 4, 5, 8, and 9;

thence northerly, between sections 4 and 5, to point 19, the section corner of sections 4 and 5 only, on the township line, Ts. 7 and 8 N., R. 15 E.;

thence westerly, on said township line between sections 5 and 32, and 6 and 31, Ts. 7 and 8 N., R. 15 E., to point 20, the township corner of Ts. 7 and 8 N., Rs. 14 and 15E.;

thence westerly on the township line of Ts. 7 and 8 N., R. 14 E., to point 21, the section corner of sections 1, 2, 35 and 36;

thence southerly, between sections 1 and 2, 11 and 12, 13 and 14, 24 and 23, 25 and 26, T. 7 N., R. 14 E., to point 22, the intersection of a line parallel with and 100 feet northeasterly of centerline of a pipeline maintenance road.

thence northwesterly, parallel with and 100 feet northeasterly of centerline of said road, to point 23, the intersection of the section line between sections 21 and 22;

thence northerly, between sections 21 and 22, 15 and 16, 9 and 10, 3 and 4, to point 24, the south 1/16 section corner between sections 3 and 4;

thence easterly, on the east-west centerline of the southwest 1/4 of section 3, to point 25, the southwest 1/16 section corner of section 3;

thence northerly, on the north-south centerline of the southwest 1/4 and the north-south centerline of the northwest 1/4 of section 3, to point 26, the west 1/16 corner of sections 3 and 34 on the township line of Ts. 7 and 8 N., R. 14 E.;

thence northerly, on the north-south centerline of the southwest 1/4 of section 34, T. 8 N., R. 14 E., to point 27, the center west 1/16 section corner of section 34;

thence easterly, on the east-west centerline of section 34, to point 28, the center 1/4 section corner of section 34;

thence northerly, on the north-south centerline of section 34, to point 29, the 1/4 section corner of sections 27 and 34;

thence northeasterly, to point 30, the 1/4 section corner of sections 19 and 24, on the range line, T. 8 N., Rs. 14 and 15 E.;

thence easterly, on the east-west centerline of section 19, T. 8 N., R. 15 E., to point 31, the 1/4 section corner of section 19 only, on the section line between sections 19 and 20;

thence northeasterly, to point 32, the east 1/16 section corner of section 20 only, on the section line between sections 17 and 20;

thence easterly, between sections 17 and 20, to point 33, the east 1/16 section corner of section 17 only;

thence northerly, on the north-south centerline of the east 1/2 of section 17, to point 34, the intersection of the southeasterly boundary of the Interstate 40 right-of-way;

thence northeasterly, on said southeasterly right-of-way boundary, to point 35, the intersection of the section line between sections 9 and 16;

thence easterly, between sections 9 and 16, to point 36, the section corner of sections 9, 10, 15, and 16;

thence northeasterly, to point 37, the south-south 1/64 section corner of sections 10 and 11;

thence northerly, between sections 10 and 11, to point 38, the south 1/16 section corner of sections 10 and 11;

thence easterly, on the east-west centerline of the south 1/2 of section 11, to point 39, the intersection of a line parallel with and 30 feet westerly of centerline of a jeep trail, said intersection located near the southeast 1/16 section corner of section 11;

thence southerly, parallel with and 30 feet westerly of centerline of said jeep trail, to point 40, the intersection of the east-west centerline of the north 1/2 of section 14,

thence easterly, on the east-west centerline of the north 1/2 of section 14, to point 41, the north 1/16 section corner of sections 13 and 14;

thence northeasterly, to point 42, the center-south 1/16 section corner of section 12;

thence northeasterly, to point 43, the 1/4 section corner of sections 7 and 12, on the range line, T. 8 N., Rs. 15 and 16 E.

thence easterly, on the east-west centerline of section 7, T. 8 N., R. 16 E., to the point of beginning.

END OF DESCRIPTION

The above description containing approximately 34,009 acres utilizes the Blind Hills, Castle Dome, Danby, Van Winkle Wash, and West of Blind Hills 7.5 minute quadrangle maps prepared by the USGS. The boundary calls listed herein are in part a result of scaling distances from said quad maps and are not a result of survey. All courses have been depicted upon the above mentioned quad maps and are made a part of this official record. Acreage is calculated from the BLM California State Office ArcInfo wilderness coverage.
